Property defined

- The word property a thing or things belonging to someone, possessions collectively
- Property in law- anything owned by a person or an entity (the law governing ownership
 - Private property- belongs to an individual
 - Pubic property-belongs to community or state

Intellectual Property

- IP is the kind of property resulting from the fruits of mental labour
- IP deals with rules of securing and enforcing legal rights to inventions and artistic woks
- IP divided into two
 - Industrial property (patents, Trademarks, Gls, Industrial designs, Trade secrets,)
 - Copyright (Literary, Musical & Artistic works)

COPYRIGHT

- Legal term describing rights creators have over their literary musical & artistic works
 - Literary (novels, poems, plays, newspaper articles)
 - Artistic works (paintings, drawings, photographs)
 - Musical works (musical compositions, films, choreography)
 - Computer programs and software
 - Architectural designs
- Protects expression of ideas not ideas or concepts
- Gives economic & moral rights

- Copyright Act CAP 130
- Rights of authorship, reproduction, distribution, communication to public, broadcasting, adaptation, translation
- Provides for remedies against infringement

Importance of IP Policy

Protecting copyright

- Two sides to copyright in academia
 - Ones right to copyright works created (creator)
 - Rights of others in the works one is using (user)
 - Copyright tries to balance between rights of owner and user
