About Bangladesh

- Name: People's Republic of Bangladesh.
- Bangladesh is a small south Asian country. It lies between 20° 34' and 26° 38' north latitude and 88° 01' and 92° 41' east longitude.
- Bangladesh is bordered by India to the north-east and west, Myanmar to the south-east, and the Bay of Bengal to the south.
- The climate in Bangladesh is sub-tropical, with temperatures ranging from a daytime low of 18° c in the winter season to a maximum of 40° c in the summer.
- Population: Around 140,000,000
- Area: 147,570 km²
- Economy: Mainly agro-based.
- Name of the IP Office: Department of Patents Designs and Trademarks (DPDT), Ministry of Industries, Dhaka.
- Head of the Department : Registrar
- Manpower: 120





IP OFFICE OVERVIEW

- previous Patent Office and the Trademarks Registry Office has been merged together and "Department of Patents, Designs and Trademarks (DPDT)" has been established which is functioning under the Ministry of Industries.
- Total manpower: 120 (Officers: 47 + Staff: 73)
- Bangladesh has inherited intellectual property system from the British regime.
- Government of the People's Republic of Bangladesh has given more importance to upgrade/modernize the IP laws keeping it in conformity with Trade Related Aspects of Intellectual Property Rights (TRIPS).



IP Functions

- for the betterment of IP protection in Bangladesh, the Govt. has taken some necessary initiatives to improve the infrastructure of the IP Office and to increase the manpower of the IP office as well as computerization of the IP System.
- for the awareness of the public, Govt. of the People's Republic of Bangladesh, organizing national seminars time to time.

IP functions contd.

- The Department of Patent, Design and Trademarks (DPDT) is the apex organization of the Government of Bangladesh for the administration of intellectual property.
- Main functions of the Department are as follows:
- (a) to administer the Patents & Designs Act 1911 and Rules 1933 for the protection of Patents and industrial designs;
- (b) to administer the Trademarks Law, 2009 and Rules 1963 for registration of trademarks;

IP functions contd.

- (c) to receive the patent applications for invention in any field of technology and examine them as to form and as to substance and grant patents
- (d) to protect patents for new inventions and innovations whether it is product or process.
- (d) to secure the protection of invention for obtaining a patent for a period of 16 years term, which is extendable up to another 10 years.

IP functions contd.

- (e) to receive & examine the industrial design applications.
- (f) to register industrial designs and maintain the registrations of such applications.
- (g) to secure the protection for registration of industrial design of a new and original industrial design for a period of 5 years, which is extendable for another two terms of 5 years each.

IP functions contd.

(h)to receive & examine the trademarks Applications.

- (i) to register the trademarks and maintain the registrations of such applications.
- (j) to provide a legal framework for enforcement and to check the unauthorized usage of trademarks and their infringement.
- (k) to protect the interest of trademark owners according to the Trademarks Act, 2009.
- (l) to dispose of the opposition and rectification cases related to patents, designs and trademarks.



Automation of DPDT

- Granting of Patents system of the Department have been partially automated under a project titled" Nationally Focused Action Plan (NFAP) for the Government of Bangladesh for Modernization of Patent Office "with the technical and financial assistance of WIPO.
- Registration of Trademarks system has also been partially automated under a separate project titled "Modernization and strengthening of Intellectual Property administration in Bangladesh" with the technical and financial assistance of WIPO.

Automation contd.

- Currently, a project under the title "Intellectual Property Rights (IPR) Project" with the technical and financial assistance from EC and WIPO is being implemented.
- Implementation of the project will ensure better service to public and private sector, industrialists and R&D institutes.
- An automated database of granted patents, registered designs and trademarks is underway that will help to enhance the IP activity in Bangladesh.
- Establishment of Bangladesh Intellectual Property
 Organization (BIPO), bringing all IP related offices under
 one umbrella organization is under process

Duties of the Registrar

- The Registrar discharges all duties and responsibilities as the Chief Executive of the Department of Patent, Design and Trademarks as per the rules and regulations of the Government.
- He also advises the Government on framing the policy relating to the technical matters of the Department.
- He exercises all powers entrusted on him by the Patents & Designs Act 1911 & Patents & Designs Rules 1933 and Trademarks Law 2009 & Trademarks Rule 1963.

Duties of the Registrar contd.

- He takes final decision on the applications received by the Department for registration purposes.
- He also acts as a tribunal for the disposal of cases of opposition and rectification.
- The Registrar issues all the legal documents of registrations related to Industrial Design and Trademarks and also grants the patent rights as per the relevant acts.

- Bangladesh is now engaged in several programs to promote the protection of intellectual property and enhance the use of intellectual property as an instrument for economic, social, technological and cultural development.
- Bangladesh has necessary laws in the areas of Intellectual Property.
- The current objectives of the intellectual property policy of our country is to update legislation, develop/improve of manpower skill, raise manpower strength and modernize the Industrial Property Office of Bangladesh through complete automation and to amend intellectual Property Laws which are originated from the British Law.

Cliental Service . contd.

- Remarkable changes in the laws to expedite disposal of cases and to incorporate the recommendations of the TRIPS Agreements are in progress.
- The Department of Patents, Designs and Trademarks is actively involved in dissemination of information contained in patent/design documents, through publications of these documents in the Bangladesh Gazettes, part-IV.

Cliental Service ..contd.

- Trademarks related information is also published periodically in the Trademarks Journal.
- This office provides information about patents and trademarks and certified copies of patents, designs and trademarks related documents available in the department to the interested members of the public.
- To create public awareness about patents and designs four inspection centers are open by the Government where publications on patent and design matters are kept for public inspection.

Quality/Performance control of DPDT

- For better cliental service the government has merged the Patent Office and the Trademark Registry Office and established Department of Patent, Design and Trademarks (DPDT).
- DPDT is committed to provide quality service to its clients and improve its performance continuously.
- Keeping it in mind this department has initiated followings:

Quality/Performance.contd.

- At the patent and design side all the applications for granting patents and registration of industrial designs are being completed in time, and there is no pending.
- While at the trademarks side 1, 44, 706 number of TM applications have been received during the period from 1971 to 2009. Among which 28, 428 number of applications have been registered up to 2009 and certificates have already been issued, Around 80, 503 number of applications are under process for registration, 35, 778 number of applications are abandoned and the remaining 4,054 number of applications applications are un-attended.
- The department took extra measures to overcome this backlog.
- This department ensures to complete all the formalities for granting patent and issuing registration within the given time frame as described in concerned acts and rules.
- While examining the applications our examiners and their supervisors tries to expedite the process following concerned rules and regulations.

Enforcement

- Enforcement of all IP laws in Bangladesh are related with the customs, police and judiciary of the country.
- National IP education in Bangladesh is not mentionable, only a few public and private Universities are teaching IP, with their limited number of IP related books and teaching materials.
- It is the time to introduce IP curriculum in all public Universities as well as private.
