

- Intellectual Property Act no.36 of 2003
- Regulations made under sec. 204 of the said Act
- By an IP agent
- By individuals

- Patent Agents

Filing an application

- Fee Structure
- Method of payment

#### Formality Examination

- Requirements (sec.71 of the Intellectual Property Act)
- Prescribed fee

#### Correction of formal defects

Within three months from the date of notification

#### **Substantive Examination**

- Inventions that can not be patentable
- Substantive Examination on novelty,
  Inventive steps and Industrially
  applicability

#### **Amendments**

- Allowed to amend an application subject to prescribed fee
- Should not go beyond the earlier discloser
- Within three months from the notification

#### Search Report

- Is an invention within the meaning of the relevant section
- Title describes the invention in a sufficient manner
- Whether claims describe the invention in a clear, concise and sufficient manner
- International Patent Classification

#### **Publication**

- To inform the public about the possibility of granting a patent
- No patent hearing by the office
- (Opposition) Must go before the courts within 3 months from the publication date

#### PCT National Phase filing

- Formality check
- Whether Sri Lanka has been designated
- 30 months calculation
- Assignments, other changes (IB 306 etc...)
- ISR
- Search report will be issued if amended at the national phase

#### **Grant of Patent**

- Valid for 20 years from the original filling date.
- After 2 years from the date of grant, patent should be renewed annually.

#### Post grant prosecution

- No opposition hearing by the office
- Invalidation under relevant sections before courts

#### Challenges

- Limited staff
- Expertise in Examination
- Awareness among the people
