## FUMIO ENOMOTO

He is Assistant Director, Coordinating Office for PCT and Madrid System, International Application Division, Japan Patent Office (JPO).

He obtained a Bachelor's Degree at Rikkyo University in 1999.

He joined the JPO in 2000. He worked in Legislative Affairs Office, General Affairs Division, from 2002 to 2004, and worked in Multilateral Policy Office, International Affairs Division, from 2005 to 2007. He became Assistant Director, Trademark Policy Section, International Affairs Division in 2007. He was transferred to the Ministry of Foreign Affairs as Second Secretary, Embassy of Japan in Greece in 2008, and became First Secretary in 2009.

He rejoined the JPO in 2011 and has been working in the current position in the JPO.

## DAISUKE NAGANO

He is Japanese Patent Attorney / Assistant Director, IP Development Center, IPR Operations Company, Panasonic Corporation. The IPR Operations Company is responsible for all IPR operations of Panasonic Group as a part of headquarters, and the IP Development Center is especially in charge of patent prosecution and administration matters.

He obtained a Bachelor's Degree in Electric Engineering from Waseda University in 1984.

He joined Panasonic as an electric engineer in 1984. After nine-year experience of developing Factory Automation equipments, he has been involved in IPR activities since 1993. He became a member of Japan Patent Attorneys Association in 1996. For over 5 years since then, he promoted effective utilization of personal interviews with JPO examiners for Panasonic cases as an in-house patent attorney.

From 1999 to 2003, he was working for a patent department office of Panasonic in Washington DC as the first representative. During his stay in DC, he passed the US Patent Bar Exam in 2000 (not registered because of VISA status restriction) and he supported to obtain many valuable US patents with building up the strong relationship between the US law firms and Panasonic. At the same time, he coordinated to make up internal training programs for IPR staffs to strengthen their skills in the US practice.

After returning to Japan in 2003, he has been in the present position and represented Panasonic before JPO in filing patent applications since April 2005.

Furthermore, he has also participated in activities of International Committee #2 in Japan Intellectual Property Association (JIPA) since 2007. As a vice-chairperson of the committee, he attended the WIPO meeting of PCT Working Group in Geneva in June 2011.

## BAEKMOON SEONG

He is Senior Deputy Director, Patent Examination Cooperation Division, Korean Intellectual Property Office (KIPO).

He graduated from Seoul National University in Seoul (Bachelor of Engineering). He also did his graduation from Korea Advanced Institute Science and Technology (KAIST) in Seoul (Master degree in Engineering).

He worked as a System Software Engineer in Hyundai Electronic Company from 1989 to 1995. After he passed the Public Administration Examination in 1996, he served in the Ministry Commerce, Industry and Energy from 1997 to 2000.
