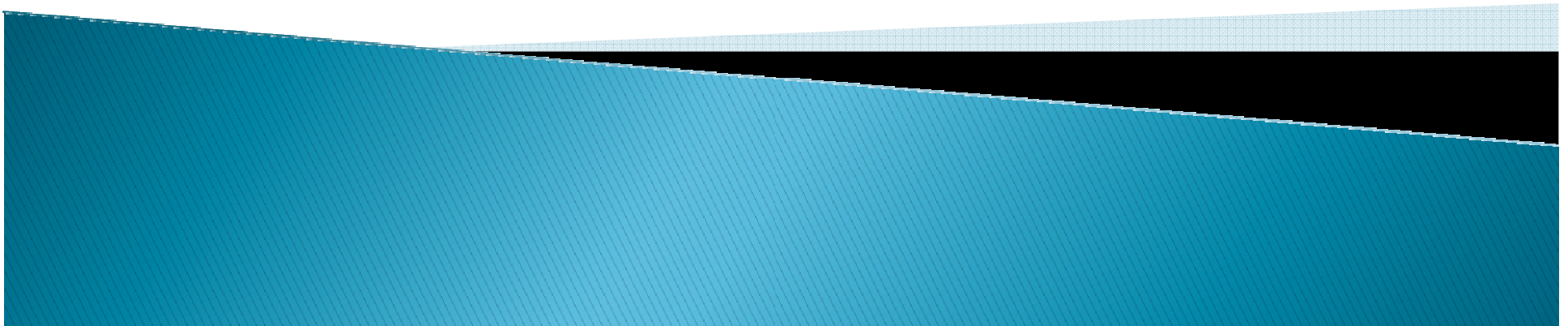


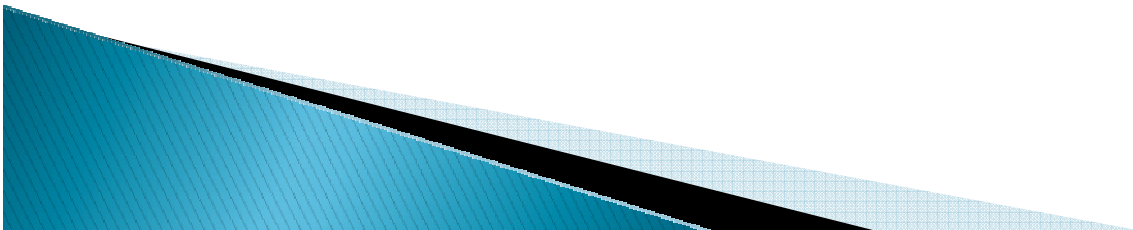

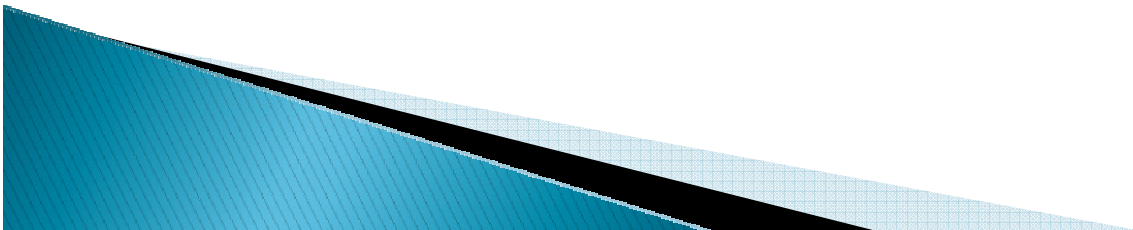
INDIAN EXPERIENCE OF PCT SYSTEM

- ▶ IN joined PCT on 7th Dec 1998 as 98th member country
- ▶ Language of filing – English or Hindi
- ▶ PCT application can be filed in all four IPO depending upon the jurisdiction of Applicant
- ▶ Competent ISA/IPEA – AT, AU, CN, EP, SE, US
- ▶ Transmittal Fee – INR 8000 (INR 2,000 for Individuals)



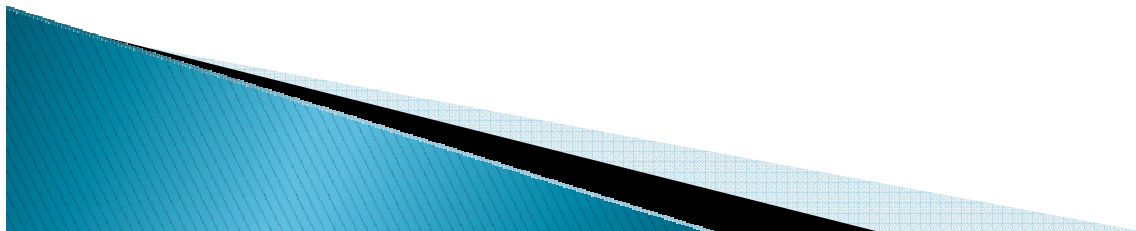
INDIAN EXPERIENCE OF PCT SYSTEM

- ▶ Int. Filing Fee – USD 1453 (Reduced by 90% if ALL the applicant are individual, national and resident of IN)
- ▶ Search Fee for EP is reduced by 75% if ALL the applicant are individual, national and resident of IN
- ▶ Foreign Filing License (FFL) required u/s 39 of the IN Act prior to filing PCT as the first patent application for inventions originating from IN
- ▶ Restoration of Priority – Not allowed

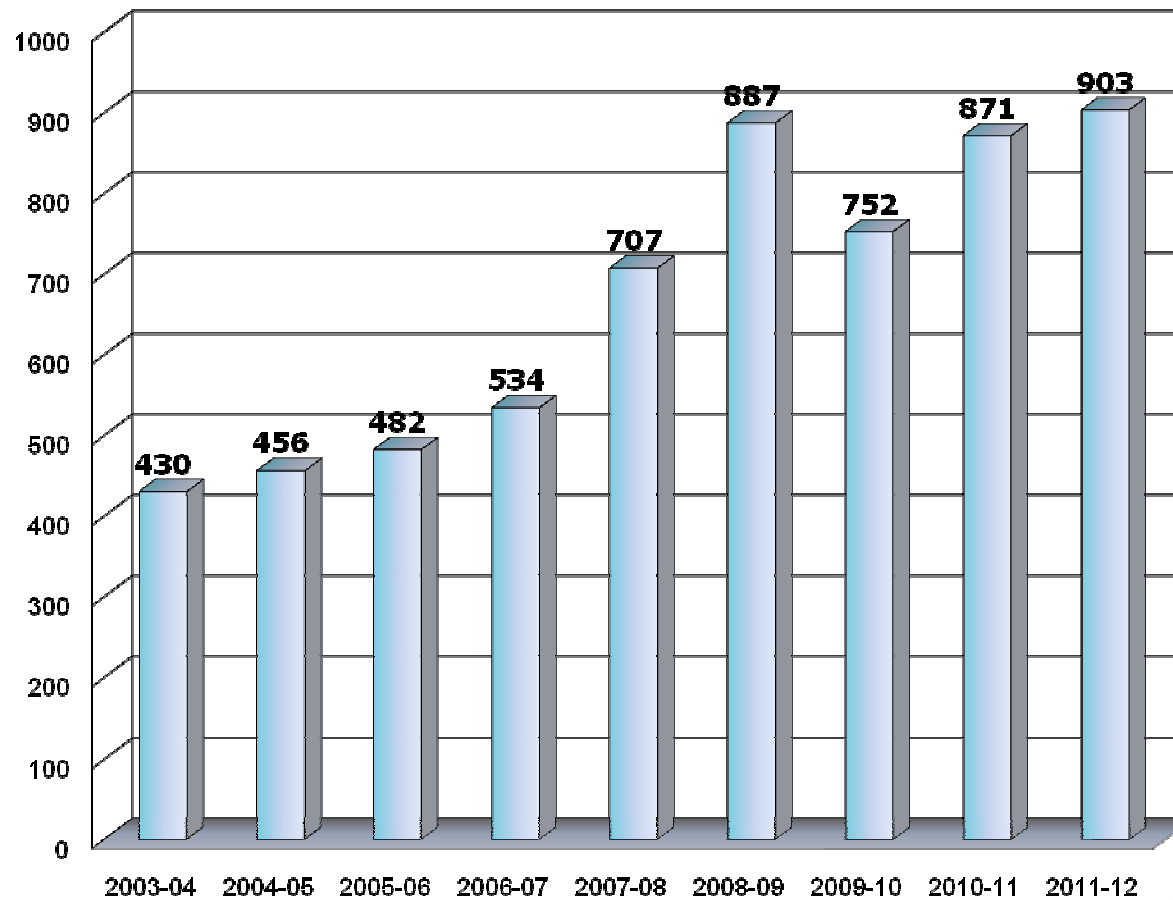


INDIAN EXPERIENCE OF PCT SYSTEM

- ▶ Time limit for entering IN National Phase – 31 months
- ▶ NP application will not be examined prior to 31 months unless express request is filed
- ▶ IN has been appointed as ISA and IPEA – yet to be operational



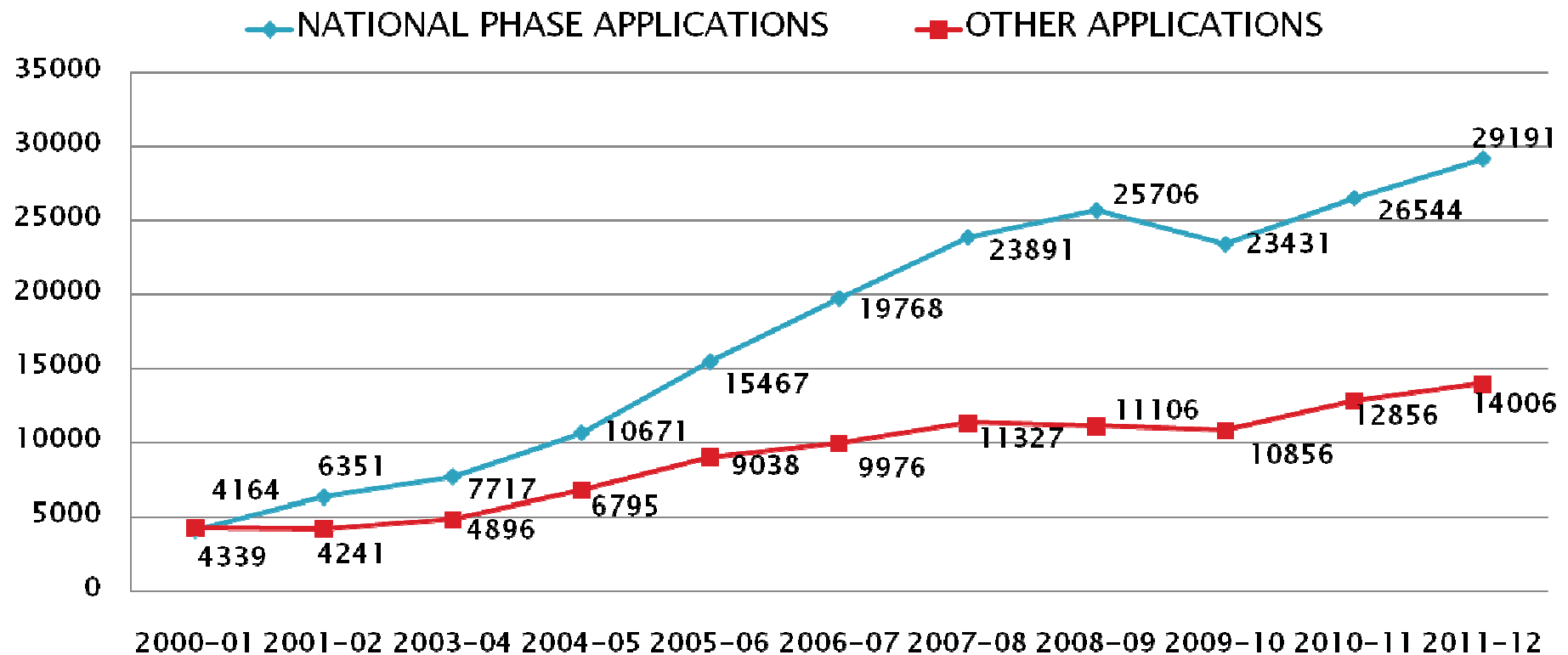

STATISTICS OF PATENT APPLNS FILED IN INDIA



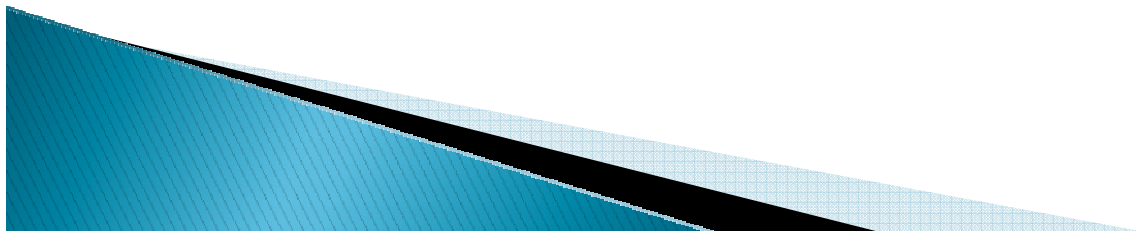
