ANJALI AERI

Ms. Anjali Aeri, a national of Canada, of Indian origin, works in the World Intellectual Property Organization (WIPO) as a Legal Officer within the Offices Services Section of the PCT International Cooperation Division, Innovation and Technology Sector.

She joined the PCT Legal Division, PCT Legal Affairs Section of WIPO in 2002, and worked extensively on the PCT Reform exercise, which brought forward significant amendments to the PCT Regulations, before working in the PCT External Legal Relations Division, providing legal advice to intellectual property Offices of both PCT contracting and non-contracting States.

Last year, she had the opportunity to work closely with ASEAN member States, while participating on behalf of WIPO in the ASEAN – USPTO Workshop on Patent, Protection, Licensing, and Enforcement, speaking about the use of the PCT system.

Following her law studies in Ottawa, Canada, and prior to joining WIPO, Ms. Aeri was employed as a Project Officer in the Patent Branch of the Canadian Intellectual Property Office (CIPO), for four years, working on various aspects relating to the national patent procedure and Regulations for Canadian applicants, as well as contributing to the amendments to the national patent policies, for the purpose of enhancing CIPO's role in the international patent community.

ROLANDO M. HERNÁNDEZ VIGAUD

Mr. Rolando M. Hernández Vigaud, a national of Cuba, is currently working in the World Intellectual Property Organization (WIPO) as Head of the Offices Services Section of the Patent Cooperation Treaty (PCT) International Cooperation Division, Innovation and Technology Sector.

Mr. Hernández Vigaud initially came to WIPO in 2000, as Senior Program Officer in the Developing Countries (PCT) Division. During that period he was responsible for the promotion of the PCT among Latin American and Caribbean countries. Later on, Mr. Hernández Vigaud worked in the PCT External Legal Relations Division and in the PCT Global Outreach Division.

Prior to taking up his duties at WIPO, Mr. Hernández Vigaud worked for twelve years at the Cuban Industrial Property Office (OCPI), where he held different posts in the Law and International Affairs Department. In 1998 he was appointed Deputy Director General of the Cuban Office and officially represented his country at various meetings including diplomatic conferences both in WIPO and the World Trade Organization (WTO).

Mr. Hernández Vigaud received his law degree from the University of Havana, Cuba and completed his Master in Intellectual Property at the University of Alicante, Spain. He has also followed various postgraduate courses in commerce and business administration and international law.
