ST.37 implementation in 2019

- All mandatory data elements covered:
Publication authority code, Publication number, Kind-of-document code, Publication date
- All document kind codes covered:
A1, A2, A3, A8, A9, B1, B2, B3, B8, B9
- All back file data covered:
since 19960701 - present
- **Monthly Updates** – Authority File and Definition File at EAPO website page: <https://www.eapo.org/en/?publs=authfile>
- **Text format**, comma separator


Authority File upgrade in 2023

- Based on **ST.37 version 2.2** of November 5, 2021
- In production **since August 1, 2023**
- **Daily Updates** at EAPO website
- New requirements to Authority Files of International Authorities under the PCT, as part of the PCT Minimum Documentation reform since 01.01.2026: **indication of text-searchable parts** available.
- Three new fields: availability of **Abstract, Description, Claims** in text-searchable format
- Automated **revision of availability of text-searchable parts done** in HIVE in June and July 2023
- New **Publication exception code “E”**: PCT regional phase entry, international application published in Russian. No corresponding full text published by EAPO.


