Introduction

- 1. The present document replaces document AB/XXII/1. It lists the items of the draft agendas of the 23 Governing Bodies (listed in document AB/XXII/INF/1 Rev.) in a consolidated manner, that is, when a matter concerns more than one Governing Body, such matter constitutes a single agenda item.

 - (iv) the preparatory documents, if any,
- (v) the action which the item calls for (in most cases, a reference to the applicable paragraph or paragraphs of the preparatory document or documents).
