AMENDMENTTOTHEREGULATIONS UNDERTHEBUDAPESTTREATY

Document prepared by the International Bureau

- 1. InJune2001, recipients of Intellectual Property Laws and Treaties were informed that the editorial part of this periodical would, with effect from the April/May 2001 is sue—which was distributed in September 2001—no longer contain the notifications under the Budapest Treaty, which would be published on WIPO's website instead. In December 2001, recipients were informed that, as from January 2002, the periodical itself would no longer be published in paper form but that it would be available, free of charge, on the WIPO website under the heading "News and Information Resources."
- 2. PresentRule13(1)oftheRegulationsundertheBudapestTreatyspecifiesthat"Any publicationbytheInternationalBureaureferredtointheTreatyortheseRegulationsshallbe madeinthemonthlyperiodicaloftheInternationalBureaureferredtointheParisConvention fortheProtectionofIndustrialProperty,"whereasArticle15(3)oftheParisConventionfor theProtectionofIndustrialProperty(ParisConvention)specifiesthat"TheInternational Bureaushallpublishamonthlyperiodical."

- 3. Havingregardtothenewpracticedescribedinparagraph 1,above,itisproposedto amendRule13bydeletinganyreferencetotheperiodicalreferredtointheParisConvention.
- 4. Theproposednewwordi ngofRule13.1givestheInternationalBureautheoptionofa publicationinpaperorinelectronicform.InRule13.2,itisproposedtoreplace,in paragraph (a),the publicationofanup -to-datelistoftheinternationaldepositaryauthoritiesin the firstissueoftheperiodicalofeachyearbythepublicationofthatlistatleastonceayear, preferablyinthefirstquarteroftheyearand,inparagraph (b),thepublicationofcertainfacts inthefirstissueoftheperiodicalbyapromptpublicatio naftertheoccurrenceofthefact.
- 5. The Annex to this document contains a proposal to a mend Rule 13 linor der to bring it in line with the current practice of publishing the notification sunder the Treaty on WIPO's website.
 - 6. The Assembly is invited to adopt the amendments to the Regulations under the Budapest Treaty asset out in the Annex to this document.
