What is Madrid Goods & Services Manager?

- Online tool for identifying and correctly classifying goods and services
- Based on the International Classification of Goods and Services (Nice Classification)



How to use Madrid Goods & Services Manager?

- BROWSE per class to select and compile goods and services from a "picklist" of terms accepted by WIPO
- SEARCH acceptable terms using keywords
- CHECK ACCEPTANCE of terms:
 - by WIPO (free text)
 - by designated Contracting Party (dCP)



What does Madrid Goods & Services Manager contain?

- Nice Classification alphabetical list of goods and services
- Harmonized terms from different classification databases

Synonyms and idioms in English, French and Spanish

What does Madrid Goods & Services Manager contain?

Includes more than 120,000 terms in English, and over 82,000 each in French and Spanish, of goods and services accepted by WIPO

What happens if a term does not appear in MGS?

- a. WIPO will reject the term
- b. If the international trademark application has been certified by a Madrid System Member, WIPO will accept the term
