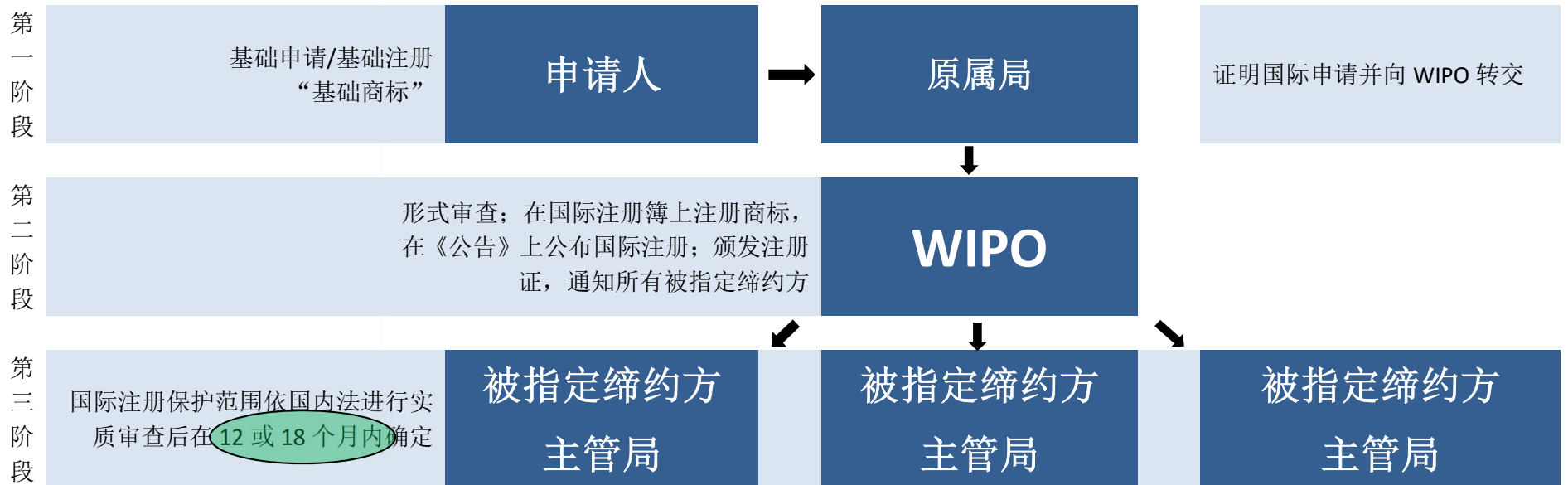
## 答案：C 112个成员，128个国家
