







新申请: 三种类型的不规范内容

依据实施细则:

■ Rule 11: 除商品/服务之外的其他不规范

■ Rule 12: 商品/服务的分类不规范

■ Rule 13: 商品/服务的名称不规范



Rule 11:常见不规范内容

- 申请人/代理人信息
- ■优先权信息
- ■商标图样
- ■商标音译
- MM18
- ■费用



Rule 11:申请人的电子邮箱

- 申请人的电子邮箱不规范(2021年2月1日起实施)
- > 未提供申请人电子邮箱

> 提供的申请人电子邮箱与代理人的相同

> 多个申请人,未提供每个申请人的电子邮箱

Rule 11:代理人的电子邮箱

■ 未提供代理人的电子邮箱(2021年2月1日起实施)

▶ 如有其他不规范情形,发送不规范通知,3个月内补正

▶ 如没有其他不规范情形,国际申请继续登记,但不包含指 定的代理人信息



Rule 11: 优先权信息不完整

■ 如多个优先权,必须提供每个优先权所对应的类别及商品/服务

案例:

Rule 11: 商标图样

■商标图样不够清晰



■ 逾期未补正,国际申请视为放弃



Rule 11: 商标音译

- ■未提供商标音译
- > 汉字等非拉丁字符,

> 非阿拉伯数字或非罗马数字



Transliteration of the mark 商标音译: GU WU XIU HUANG

Rule 11: 费用

 The amount of the fees available in the account N° 101982 opened with WIPO is less than the amount required (Rule 9(3)).

In order to remedy this irregularity, the missing amount should be paid to the International Bureau:

Rule 12 & 13: 造成不规范的可能原因

■新旧版本尼斯分类的修改变化

■ 国际局与国家局之间对某些商品/服务的不同意见

■翻译问题

■ 商品/服务清单中的标点符号使用不当



- ➤ loading apparatus for furnaces: 从 11类 移到 7 类
- ➤ insulating gloves: 从 17 类 移到 9 类
- > needles for wool combing machines:

从 26类 移到 7 类

➤ harpoon guns [sports articles] 从 28类 移到 13 类

o 商品/服务必须按照**现行版本尼斯分类的类别**申请



- > wet suits for water-skiing: 从 25 类 移到 9 类
- ➤ bags for microwave cooking: 从 16 类 移到 21 类
- ➤ hospital beds:从 20 类 移到 10 类
- toilet paper dispensers:
- o toilet paper dispensers of metal 从 21 类 移到 6 类
- o toilet paper dispensers, not of metal 从 21 类 移到 20 类



- ➤ ticket dispensers: 从 9类 移到 7类
- ticket dispensing terminals, electronic (9类)
- queue ticket dispensers of metal (6类)
- o queue ticket dispensers, not of metal (20类)



Rule 12: 典型案例

- 在7类申请 solenoid valves (电磁阀): 移到第9类
- 在7类申请 soy milk making machines (制豆浆机):

移到11类

■ 在9类申请 glass cloth/eyeglass cloth (擦眼镜布): 移到21类,同时建议翻译为"eyeglass cleaning cloths"

- 在21类申请 clothes hangers (衣架): 移到20类
- 如翻译为drying racks for laundry 或 clothes drying hangers (洗衣用晾衣架)则应在21类

Rule 12: 典型案例

■ 在30类上申请cooking wine (料酒): 移到33类

■ 在35类申请 advertisement (广告): 移到16类

➤ 如修改为 "advertising" 则符合35类

■ 在42类申请 installation and repair of computer hardware(电脑硬件的安装及维修): 移到第37类



Rule 12: 不规范通知回复期限

IRREGULARITY (IES) CONCERNING THE CLASSIFICATION OF GOODS AND SERVICES: TO BE REMEDIED BY THE OFFICE OF ORIGIN (Rule 12).

1. The International Bureau considers that the goods and/or services listed in the international application are not grouped in the appropriate classes of the International Classification of Goods and Services (Rule 9(4)(a)(xiii)). The International Bureau proposes therefore to transfer the following terms:

"glasses cloth" from class 9 to class 21 - by analogy with the basic number 210077 of 11-2021 edition of NICE Classification, and please reword it as "cloths for cleaning glasses".

The proposed grouping may entail the payment of further fees (see attached accounting statement).

An opinion on this proposal may be communicated to the International Bureau. Any such opinion must be communicated THROUGH THE OFFICE OF ORIGIN within three months from the date of the present notification, that is by 11 June 2021. Failing this, the mark will be registered with the classification and grouping proposed by the International Bureau. However, if this proposal entails the payment of further fees and such fees are not paid within four months from the date of the present notification, the international application will be considered abandoned.

Rule 13: 商品/服务的名称不规范

- 三种情形:
- ▶ 表述过于含混,不便分类: too vague

➤ 费解: incomprehensible

➤ 用词不正确: linguistically incorrect



Rule 13: 标点使用不当

- 用分号";"来分隔商品/服务项目
- 在同一项目之内,用逗号","来停顿
- > 案例:
- Cl. 35 Retail and wholesale of shoes; clothes; hats. X
- Cl. 35 Retail and wholesale of shoes, clothes, hats. √

- Class 16 Envelopes; scissors: paper. X
- Class 16 Envelopes; scissors; paper. √



➤ Cl. 10: aerosol dispensers for medical purposes (医用气雾剂分配器)
从12-2023版尼斯分类开始,**不再接受**

修改为: nebulizers for medical purposes (医用雾化器)



➤ Cl. 20: valves, not of metal, other than parts of machines (非金属阀(非机器部件))
从12-2023版尼斯分类开始,不再接受

修改为: valves of plastic, other than parts of machines (塑料阀门(非机器部件))



➤ Cl. 22: network (网织物) 从12-2023版尼斯分类开始,**不再接受**

修改为: nets 或者 netting for protection against birds and insects



➤ Cl. 29: albumen for culinary purposes (烹饪用蛋白) 从12-2023版尼斯分类开始,**不再接受**

修改为: white of eggs (29类)

或: proteins for the food industry (1类)



➤ Cl. 30: meat tenderizers, for household purposes (家用嫩肉剂)
从12-2023版尼斯分类开始,**不再接受**

修改为: meat tenderizers for culinary purposes


