PROOF OF CONCEPT OF A SEARCHABLE ONLINE CATALOGUE FOR DEVELOPMENT AGENDA PROJECTS AND OUTPUTS

prepared by the Secretariat

1. The Committee on Development and Intellectual Property (CDIP) at its twenty-fourth session, approved a project submitted by the Delegations of Brazil, Canada, Indonesia, Poland and the United Kingdom on Tools for Successful Development Agenda Project Proposals, contained in document [CDIP/24/14 Rev..](#)
2. One of the project outputs is the creation of an online searchable Catalogue, containing all past and ongoing DA projects together with additional information on each project, including a reference to the beneficiary countries (where applicable), main project activities and outputs, implementation start and end dates, outcomes and achievements, and progress and evaluation reports and recommendations. This document describes the proof of concept of the online searchable Catalogue, currently under development in the context of the above-mentioned project.
3. The metadata that will be used for developing the final product will consist of the information contained in all DA project documents, progress reports, evaluation reports, completion reports, and outputs of DA projects (studies, guidelines, databases).
4. The proof of concept was created on the basis of the information collected from eight project documents. The visual design of the Catalogue will be finalized once the final product will be developed, and made available on the WIPO website.
5. When developing the proof of concept of the Catalogue, the following expected user groups were identified: (i) Member States wishing to present project proposal(s) to the CDIP (this is the main user group identified); (ii) Member States interested in benefiting from

activities emanating from DA projects; (iii) project managers (WIPO staff); and (iv) information seekers.

6. Hence, the Catalogue will be developed around the information model presented in Annex I to this document, structuring the information flow in two main clusters: selectable information (grey boxes), and additional information (white boxes). Below is the list of information clusters by which the users will be able to refine the search in the Catalogue:

- DA Recommendation cluster;
- DA Recommendations;
- DA projects (this will include the completed and ongoing projects);
- Activities undertaken in the context of the implementation of DA projects;
- Implementing WIPO Program;
- Beneficiary countries;
- Project document code;
- IP fields;
- Project outputs.

7. The Catalogue will also provide additional results that will be easily accessible, once the information has been already refined or at the start of the user's search. The additional results will include information on the following:

- WIPO Strategic Goals;
- Link to the CDIP session when the document was approved or discussed;
- Reports (this will include progress reports, completion reports, and evaluation reports);
- Total expenditure;
- Project budget;
- Project outcomes;
- Related documents;
- Project mainstreaming.

8. In addition to refining by selecting the categories mentioned in para. 6, the Catalogue will also permit full text searching in six official UN languages, based on the availability of the documents used for developing the metadata of the Catalogue.

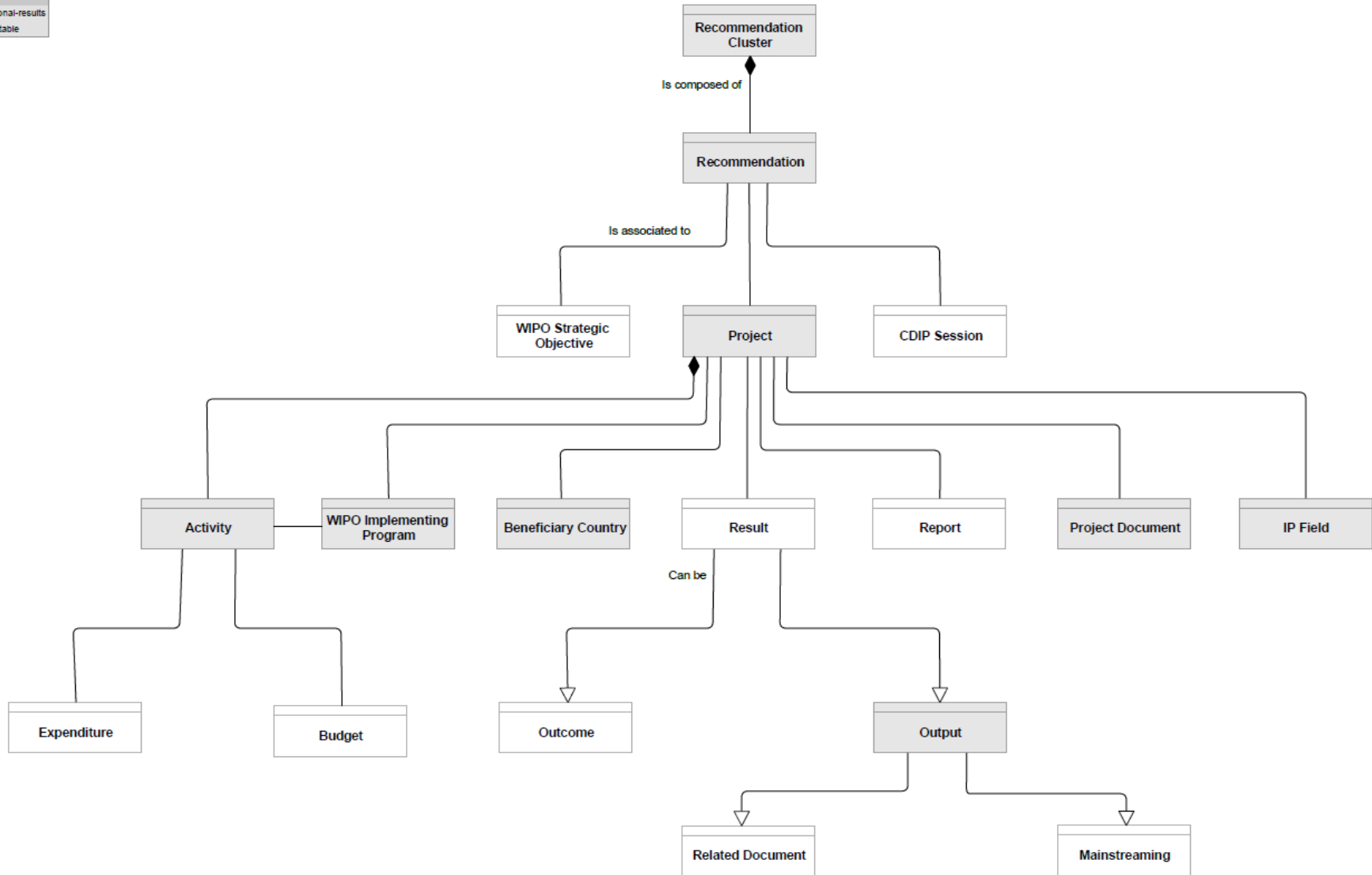
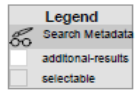
9. The Catalogue will be designed in a way that any new relevant material (projects, outputs, reports) could be easily updated to the platform. This will ensure that the information contained in the Catalogue will be always accurate and up to date.

<u>Title</u>	<i>Intellectual Property, Tourism and Culture: Supporting Development Objectives and Promoting Cultural Heritage in Egypt and other Developing Countries</i>
<u>Development Agenda Recommendations</u>	<p><i>Recommendation 1:</i> WIPO technical assistance shall be, <i>inter alia</i>, development-oriented, demand-driven and transparent, taking into account the priorities and the special needs of developing countries, especially LDCs, as well as the different levels of development of Member States and activities should include time frames for completion. In this regard, design, delivery mechanisms and evaluation processes of technical assistance programs should be country specific.</p> <p><i>Recommendation 10:</i> To assist Member States to develop and improve national intellectual property institutional capacity through further development of infrastructure and other facilities with a view to making national intellectual property institutions more efficient and promote fair balance between intellectual property protection and the public interest. <p><u>Brief Description of Project</u></p>	<p>Implemented in four pilot countries, i.e. Ecuador, Egypt, Namibia and Sri Lanka, the project aimed at building capacities of key stakeholders and raising awareness of the intersection between IP tourism and development, in the framework of growth and development policies.</p> <p>Why focus on IP and Tourism?</p> <p>The project stemmed from a proposal of the Arab Republic of Egypt, approved by CDIP/15, to consider the role of the IP system in promoting tourism-related economic activity, including activity related to the promotion of national and/or local knowledge, traditions, and culture.</p> <p>The project was developed on the fundamental premise that tourism, one of the major players in international commerce, represents one of the main sources of income for many developing countries. Tourism demand is increasingly differentiated by a market that proposes value-added products and services. In this context, tourism stakeholders can play a key role in providing high-quality products and services to tourists by responding to their most specific interests and needs. In so doing, both consumers and providers of tourism products and services can benefit from the strategic use of the IP system.</p> <p>Based on research conducted in the four pilot countries, the project took a close look at practical experiences and made a series of recommendations to assist tourism stakeholders adopt appropriate strategies and tourism-related policies to support business competitiveness and local development.</p> <p>The project also addressed the needs of raising awareness at the academic level of the intersection between IP, tourism and development, and was instrumental in stimulating academic debate on a new research topic. This resulted in the development of new curricula and teaching materials to be integrated in the academic programs of selected universities in pilot countries.</p> <p>Finally, the experiences and best practices documented throughout the project were consolidated in a series of national studies and in a practical guide, which highlight several options to use the IP system to promote tourism and cultural heritage, while supporting development objectives at local and national levels.</p>
