





IP Applications by geographical region 2010 - Source WIPO 2011



(11142 scientific articles ~ 1.4% world production)






#### **Informal Sector**

#### Lack of National Strategy for IP/Weak National Innovation System

 The R&D, strategy, and legal functions are poorly integrated Stakeholders miss opportunities to create and exploit the value of intellectual property

- The lack of a common framework that would allow stakeholders to develop an approach to IP that is broad in its outlook and integrated with the country's strategy
- IP management is restricted to <u>NOTARY FUNCTIONS</u>

- Grant of 90% on the fee for filing an patent application
- Publication taxes are waived
- Maintenance fees from 2nd to 10th year 80% reduction of annuity
- the Fund for Aid to the Promotion of Invention and Innovation (FAPI) instituted by OAPI.
