Two takeaways

Latin-America countries do not have the necessary copyright exceptions to carry out text and data mining.

National AI strategies are not considering copyright as a dimension for AI development.





Latin-America Copyright Overview

- Civil Law countries: Droit d'auteur
- Closed-list for copyright exceptions
- Multiple regional integration initiatives but with few development on copyright regulation
- Berne Convention + TRIPS Agreements + WIPO internet treaties
- WIPO (2009): 'Countries have not developed a specific set of rules concerning limitations or exceptions to the copyright applicable to the **digital environment**'

Observations in LATAM

Lack of specific exceptions for TDM

All of them have education exceptions but in a limited-traditional sense: “quotation” or “education purposes”

Limits reflect how exceptions are still drafted to focus on traditional educational activities and not technology-based processes

Legislation refers to “Exceptions for Research” or “For Personal Study” instead of “Right to Research”

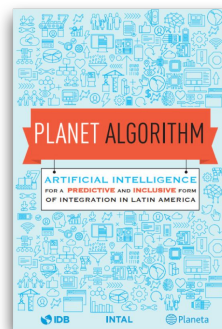

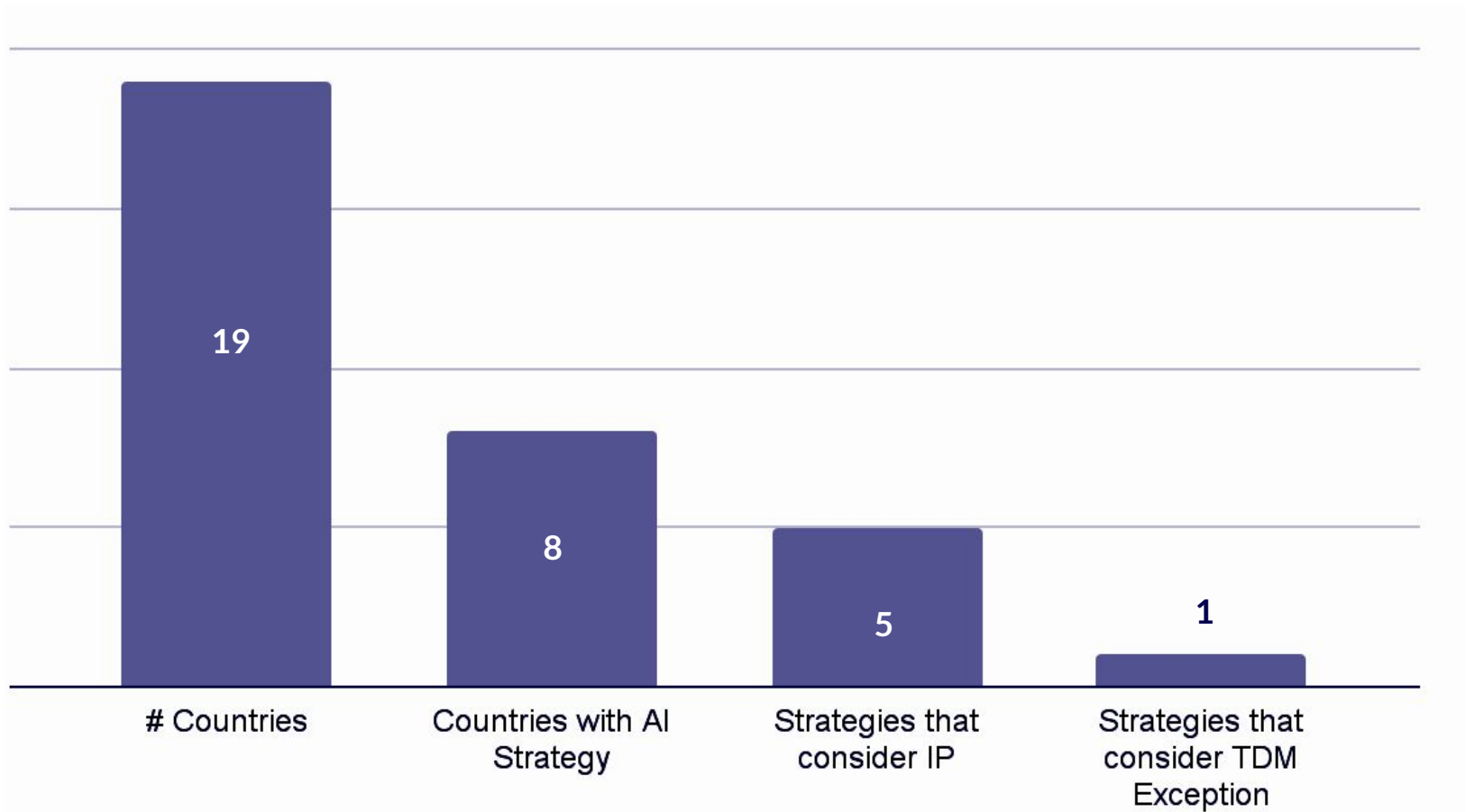
