- In principle, Indonesia views the SSTC as a strategy in achieving Indonesia's development targets.
- SSTC is viewed as an effective way to help achieve the 2030 SDGs Agenda for Southern countries.
- Indonesia views SSTC as a complementary program to North-South Cooperation.
- For Indonesia, the partnership and involvement of developed countries and other partners such as International Organization with Southern countries through Triangular Cooperation is an effective way to deliver more concrete projects with less burden of resources for all parties involved.

### Indonesia's View on SSTC

## SSTC implementation principles in Indonesia

- Demand driven → based on potential, priority needs, and requests from recipient countries
- Non-conditionality → inclusive partnerships, and do not create interdependence.
- Alignment with national development → The alignment of the SSTC with national development policies is a driving factor in accelerating the achievement of national development goals.
- Comprehensive and sustainable → SSTC planning is carried out in an integrated, comprehensive, coordinated, and continuous manner.
- Transparent and accountable.
- Equality and mutual respect.
- Mutual opportunity and mutual benefit.

How Indonesia implemented the SSTC program  Indonesia implement SSTC mainly through the Indonesian Agency for International Development (Indonesian AID).

• Its main mandate is to manage government investment funds allocated to international development cooperation (endowment funds), as well as planning and implementing the distribution of funds for grants to implement and carry out projects.

#### Grant Process for SSTC in Indonesia

Based on Government Regulation No. 48 of 2018

Submission of grant proposals from Indonesian Representatives to the Ministry of Foreign Affairs

## Some examples of SSTC Cooperation Carried out by Indonesia

- United Nations Development Programme (UNDP),
  - → Strengthening Innovative Partnership for Development Cooperation (SIP-DC) program. Strengthening and developing new partnerships for development cooperation.
  - → Strengthening Government policies and regulations in the management of foreign aid
- Japan International Cooperation Agency (JICA)
  - → Capacity Development Project for South-South and Triangular Cooperation (CADEP-SSTC) This program is implemented as efforts to strengthen coordination and institutional framework and develop cooperation innovative in the implementation of SSTC.
- United States Agency for International Development (USAID),
  - → Strengthening the capacity of the Government of Indonesia to provide strategic, effective and fruitful development cooperation in beneficiary countries.

## Indonesia's Experience in WIPO CDIP DA Project

- Indonesia has been part of 4 DA Projects within the framework of CDIP in WIPO.
- As beneficiary only
  - IP and Socio-Economic Development Phase II (2015-2018) completed and mainstreamed
  - IP Management and Transfer of Technology: Promoting the Effective Use of IP in Developing Countries, Least Developed Countries and Countries with Economies in Transition (2018-2020) – completed and mainstreamed
- As co-sponsor
  - Project proposal by Brazil, Canada, Indonesia, Poland and the United Kingdom on Tools for Successful Development Agenda Project Proposals – completed
- As main proponent and beneficiary
  - Promoting the Use of Intellectual Property in Developing Countries in Creative Industries in the Digital Era (2022-2024) – in progress

### SSTC as a Vehicle to implement WIPO DA

- DA Projects are one of the main concrete deliverables in the implementation of the wider WIPO Development Agenda (DA).
- SSTC as a vehicle to implement WIPO DA could begin by delivering DA Projects that has been completed by beneficiaries countries through more countries with WIPO supports and facilitation.

### SSTC as a Vehicle to implement WIPO DA

- Benefits of delivering DA Projects through SSTC:
  - For countries who have implemented the projects
    - Helped in ensuring institutionalization and sustainability of impacts from completed projects.
  - For new beneficiaries countries
    - Implementation of projects would already take into account all risks and risks mitigation strategies learned from the previous implementation in pilot countries.
  - For WIPO
    - Easier to mainstream and promote completed DA projects.
    - Could deliver more projects with less resources, especially on experts used (personnel costs).

## Reflections and Way Forward

- Combining WIPO Match and the DA Project Catalogue (one of the outcomes of the Project on Tools for Successful DA Project Proposals) that would serve as "a la carte menu" that could be used by WIPO Member Countries to explore the possibility of SSTC.
- Mainstreamed DA Projects within WIPO will not be dormant. WIPO could use SSTC to actively match the need from a Member State with another Member State who has successfully implemented DA projects in particular subjects.
- In short, more projects would be mainstreamed, sustainable, and delivered in more beneficiaries with less resources for all parties involved within the SSTC framework.
