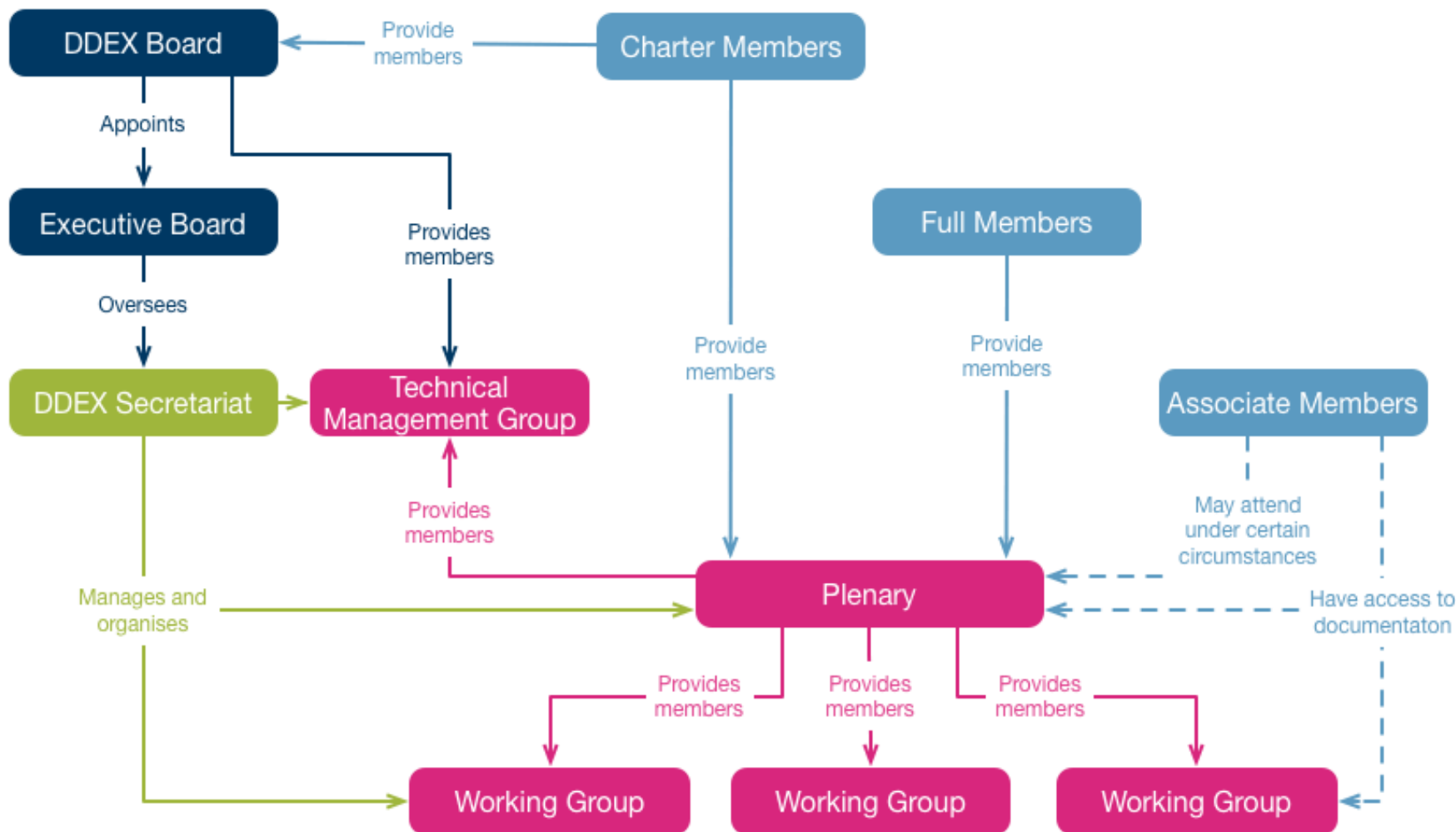
Digital Data Exchange, LLC

Underpinning DDEX's Standards

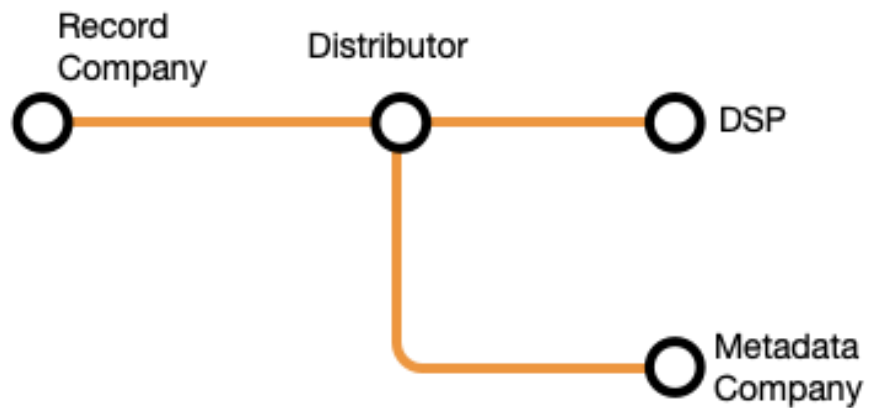
- DDEX defines the “lingua franca” for the music industry

 - Structure of common composites

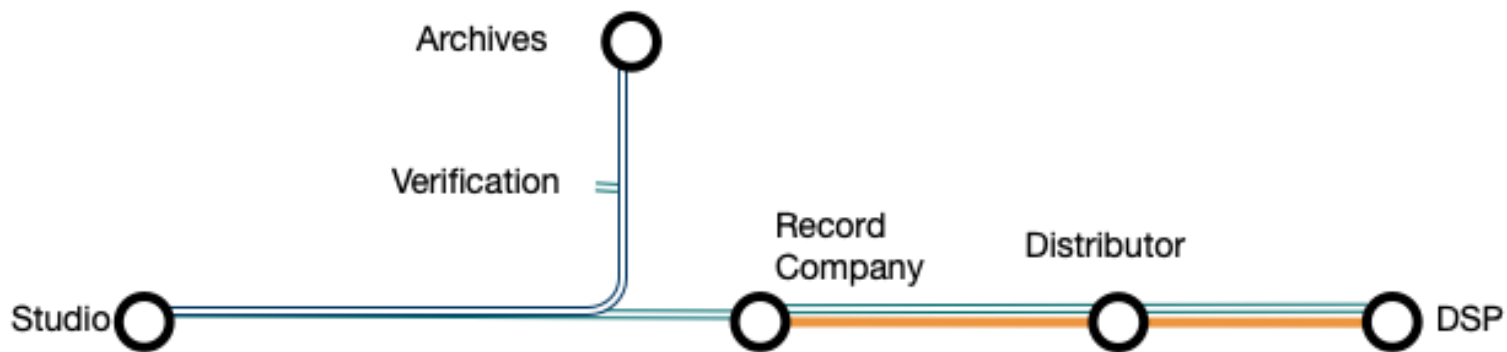
