CURRENT SALES OF PATENT OFFICE PUBLICATIONS

Memorandum prepared by the International Bureau

- 1. This document presents, in its Annex, a summary of information received from a number of Patent Offices concerning the sale of their published patent documents (first publication) and Official Gazettes. This information may be useful in the discussions on document PCT/WG/BUD/I/2 entitled "Budgetary requirements of the International Bureau" which presents various estimates of expenditure and income of the International Bureau operating under the PCT. The said income would derive from three sources only: international fees, sales of pamphlets and sales of Gazettes.
- 2. The Patent Offices of the following countries were asked to supply information: Canada, France, Germany (Federal Republic of), Japan, Netherlands, Sweden, Switzerland, United Kingdom and United States of America. The information requested was as follows:
 - (a) As to Official Gazettes:
 - (1) Number of subscribers.
 - (2) Subscription fee per year
 - (3) Whether subscription fee included postage
- (b) As to first publication of patent applications (or patents, where applications are not published):
 - (1) Average number of copies sold
 - (2) Price per single copy.
- 3. It will be noted that the figures given relate only to sales of paper copies and do not cover sales of patent documents in microform.
