# REVISION AND ESTABLISHMENT OF WIPO STANDARDS RELATING TO TRADEMARKS

Document prepared by the Secretariat

#### Introduction

- 1. In July 2001, following the first session of the Standards and Documentation Working Group (SDWG) of the Standing Committee on Information Technologies (SCIT), and as mandated under Task No. 20, the International Bureau issued a circular and questionnaire to industrial property offices (IPOs) for the purpose of collecting data on formats currently in use for figurative elements of marks.
- 2. At the second session of the SDWG, held from December 2 to 6, 2002, the document SCIT/SDWG/2/9 (which included the questionnaire and its circular) was presented to the SDWG with the collated results of the questionnaire. The SDWG agreed that the results of the questionnaire should further be analyzed and a report be prepared and presented to the third session of the SDWG.
- 3. At the second session of the SDWG, the Korean Intellectual Property Office (KIPO) also made a proposal to revise existing, or as necessary, create new WIPO Standards relating to trademarks. The SDWG agreed to establish a Trademark Standards Task Force with the mandate to prepare a project brief on the said proposal. KIPO was designated as Task Force Leader.

- 4. At the third session of SDWG, held from May 5 to 8, 2003, the Secretariat presented the results of the analysis of the data collected from the questionnaire in a document titled "Report on the Survey on Formats Currently in Use by Industrial Property Offices (IPOs) for Figurative Elements of Marks" (SCIT/SDWG/3/5). A number of issues were identified and noted during the discussions, in particular: the capture and manipulation of three dimensional objects, color management, the desired size for images (whether expressed in centimeters or pixels), and software licensing issues, e.g., for GIF software. The SDWG agreed to further work on these issues and to subsume Task No. 20 within the mandate of the Trademark Standards Task Force.
- 5. As requested by the SDWG, on October 16, 2003, KIPO submitted a project brief for revising or establishing WIPO Standards for trademarks. The project brief is contained in Annex I to this document.
- 6. The Task Force also carried out a survey to determine which standards have priority. This survey is covered in Annex II, including its Appendix, and Annex III to this document.
- 7. An oral progress report of the work carried out by the Task Force will be presented at the current session of the SDWG in order to inform the Working Group on the status of the revision or establishment of WIPO Standards for trademarks.

#### 8. The SDWG is invited:

- (a) to note the contents of the project brief prepared by the Trademark Standards Task Force as given in Annex I of this document; and
- (b) to consider and agree to the proposals concerning the elaboration of a standard for the capture and display of the figurative elements of marks and the development of XML standards for electronic processes of trademark data.

#### ANNEX I

# PROJECT BRIEF FOR REVISING OR ESTABLISHING WIPO STANDARDS FOR TRADEMARKS

#### Clear indication of the problem or specific needs to be addressed

1. The WIPO website highlights the importance of standards:

In the framework of the international cooperation promoted by WIPO in the field of industrial property information and documentation, standardization efforts have resulted in 48 WIPO Standards, Recommendations and Guidelines related to patents, trademarks and industrial designs. These WIPO Standards facilitate the harmonization of practices by industrial property offices (IPOs) regarding electronic data processing in respect of the procedures for filing, examination, publication, granting and registration of industrial property titles. WIPO Standards also facilitate the international transmission, exchange, sharing and dissemination of industrial property information (text and images), as well as the access to and retrieval of the said information.

- 2. The two important aims of the WIPO Standards are, firstly, to give criteria to IPOs that wish to improve the means of exchanging documents related to intellectual property (IP) and, secondly, to guide IPOs that wish to set up new procedures or improve the quality of their work. Although these standards offer practical guidance for patent documents, they inadequately deal with trademark documents. They should include the same level of detail that is offered for patent documents.
- 3. The need to create standards or recommendations for the electronic exchange of trademark data is especially urgent. Some trademark offices electronically receive trademark applications and exchange trademark documents with other offices. Under the Madrid Agreement and Protocol, for example, offices can electronically exchange data with WIPO through the Madrid Electronic CommunicAtions (MECA). Although MECA is a *de facto* exchange standard, it does not cover all aspects of the electronic management of trademark data, nor does it respond to all the needs of the different offices. Standards are needed for interoperability across offices.

#### How the need was determined

4. At the second session of the Standards and Documentation Working Group (SDWG) of the Standing Committee on Information Technology (SCIT), held in December 2002, the Korean Intellectual Property Office (KIPO) proposed the revision or, if necessary, the creation of 11 standards (see document SCIT/SDWG/2/4). Support for KIPO's proposal was widespread. The SDWG agreed to establish the Trademark Standards Task Force with a mandate to prepare the following:

- (i) a detailed project brief elaborating the objectives of the task;
- (ii) a clear description of the need for and benefits of each proposed standard;
- (iii) a prioritization of the list of proposed standards.
- 5. At its third session, held in May 2003, the SDWG discussed the progress of Task No. 20 regarding the figurative elements of marks. It agreed that this task fell under the mandate of the KIPO-led Task Force that deals with the standardization of trademarks (see document SCIT/SDWG/3/5).
- 6. The Task Force held an informal meeting during the third session of the SDWG to discuss how to deal with the proposed standards, and it agreed to conduct a survey to prioritize the proposed standards.
- 7. The Task Force received a new proposal for an XML standard to address trademark data from its members. It added the two proposed standards regarding the figurative elements and the XML standard to the 11 standards proposed by KIPO. It carried out the survey to provide the order of priority for the 13 proposed standards. It agreed to focus on the two standards with the highest priority, namely, the figurative elements of marks and the XML for trademarks, and to deal with the other proposed standards later on (see Annexes II and III).

#### Objective of the tasks

- 8. The general objective of the tasks is to revise the WIPO Standards or, as necessary, to create new standards for trademarks to improve procedures for the filing, examination, publication, granting and registration of trademarks.
- 9. In the first phase, the main objective is to elaborate a standard for the capture and display of the figurative elements of marks and to develop XML standards for electronic processes such as e-filing and the exchange of trademark data.

#### Options for solutions

- 10. In the first phase, one of the activities of the Task Force is to conduct a survey of States Members of WIPO on their practices regarding image format.
- 11. The Task Force should survey Members States practices with regard to the capture and manipulation of three-dimensional objects; color management, particularly with respect to the increasing requirements of electronic filing, the desired size for images (whether expressed in centimeters or pixels), and software licensing issues, for example, GIF software.

- 12. At the beginning of 2004, the Task Force will prepare a questionnaire for the survey in order to set up a new standard (or recommendation) for the capture and display of the figurative element of marks. The International Bureau (IB) will then distribute the questionnaire to IPOs.
- 13. The newly established standard will be on the results of the survey. Through that standardization, the Task Force will be able to finish SDWG Task No. 20 in 2004.
- 14. Thereafter, the Task Force should prepare XML standards for e-filing and the electronic exchange of trademark data between trademark offices. This standard will be based on the MECA-XML DTD. The Task Force should modify MECA-XML DTD to cover all the needs of the different offices and to harmonize with the related patent standards. The SDWG needs to set up a new task for this standardization.
- 15. The Task Force will prepare the draft of the standard and publish the revision of the draft two or three times in 2004. The Task Force will be able to set up the standard in 2005.
- 16. After the first phase, the Task Force will consider the remaining 11 proposed standards. While establishing the XML standards, the remaining proposed standards can be partially addressed.

#### Expected benefits

- 17. In general, the standards are expected to provide better guidance on trademarks for IPOs wishing to set up procedures or improve the performance of their work. Through the revised WIPO Standards, WIPO can help IPOs to harmonize their electronic data processing practices for the filing, examination, publication, granting and registration of trademarks.
- 18. The new standards should facilitate the e-filing of trademarks, as well as the international exchange of trademark data (text and images) between trademark offices.

#### ANNEX II

# SURVEY OF REQUESTS FOR REVISION OR ESTABLISHMENT OF WIPO STANDARDS RELATED TO TRADEMARKS

#### Background

- 1. In 2002, the Korean Intellectual Property Office (KIPO) submitted a request to the second session of the SCIT/SDWG regarding the revision and establishment of 11 WIPO Standards related to trademarks (see Annex I to document SCIT/SDWG/2/4). The SDWG agreed to set up a Trademark Task Force to deal with the request. The Task Force has received two additional proposals for the establishment of WIPO Standards. The Task Force needs to consider the 13 standards proposed.
- 2. The Task Force discussed how to manage the proposals and decided to conduct a survey to determine which standards have priority. The Task Force will focus on the two or three standards that have priority.

#### Purpose of the survey

3. The survey aims to prioritize the standards proposed for trademarks.

#### How to fill out the table in the Appendix

- Mark your priority in the fourth column of the table from 1 to 13 where 1 is the highest priority and 13 is the lowest;
- Mark I (interested) or U (uninterested) in the fifth column to indicate if you have an interest in or would potentially implement the particular standard;
- Mark the WIPO Standard ST.3 code for your Office in the sixth column.
