- with full regard and respect to the competences of the Community institutions




Activity in the first seven years (1996- 7 November 2003) FACTS AND FIGURES

- First filings of RCD at OHIM: 1 April 2003, with lead-in period beginning 1 January 2003
- Objective: Publication of registrations without deficiencies within 3 months






