


Present Status of SMEs

Present Status of SMEs 1




- □ Number of SMEs approx. 4.2 million, over 99% of all companies in Japan
- ☐ Percentage of patent applications by SMEs steady at 10-12% of the annual total

Definition of small and medium-sized enterprises (SMEs)

In the manufacturing sector, companies with capital below JPY300 million and less than 300 regular employees.



The rate of annual patent
applications by SMEs is steady at
10-12% (30-40 thousand cases/yr).

SME percentage of the annual
total of applicants is 48-57% (1214 thousand applicants/yr).

Note: While utility model
applications by large enterprises
constitute less than 10% of the
annual total, apps. by SMEs are
approx. 40-50% (3-4 thousand
cases/yr). SME percentage of
applicants is approximately 50%
(2.5-3.0 thousand applicants/yr).

Anti-counterfeiting (66%); Market penetration (56%); Competitor countermeasures (38%); and Licensing (32%)

Compared with large enterprises, utilization rate of patents by SMEs is higher.

. The number of patent applications by SMEs is low since SMEs thoroughly select applications. When SMEs obtain application rights, they tend to exploit them effectively.


Rate of Patent Utilization by SMEs	Rate of Patent Utilization by Large Enterprises

SME percentage of the annual total trademark applications is steady at 52-53% (48-62 thousand cases/yr).


Note: A large number of trademark applications are filed by very small enterprises so it is uncertain whether the majority of enterprises are SMEs.

SME percentage out of the total number of applicants is annually 65-70% (21-26 thousand cases/yr).

Relationship between Corporate Performance and IP Activities by SMEs





. SMEs that developed their own patented products through independent R&D activities tend to achieve higher operating profits. Further, protection that includes overseas rights prevents patent infringement and contributes to even higher profit margin for SMEs.



. Active patent acquisitions increase SME recognition and assist in expanding sales. This effect is particularly apparent in venture firms that are involved in IP activities from an early stage.

Effects of IP Acquisition for Hit Products

The smaller the scale of operations, the higher the proportion of SMEs feeling "credibility was increased" and "it became easier to

Awareness of Intellectual Property (IP in general) by SMEs



☐ SMEs have various concerns about IP and their expectations for official assistance are diversified.

Concerns about IP⁵

(1) SMEs think IP is "difficult to understand" and "irrelevant" for them. What lies at the base of their perception is the high initial hurdle.

(2) Even those with the intention to address IP have the following concerns:

Expectations for Official Assistance

(According to replies from 620 SMEs for a survey conducted in Dec. 2009.)

Due to lack of professional / technical knowledge.

Do not know:

.How to patent their inventions.

.How to search prior art invented by other companies.

.How to fill out application documents.


.How to find a good specialist such as a patent attorney.

.Due to lack of personnel / funds.

- Expenses for patent application such as patent attorney's fees are expensive.
- Not having the knowledge to establish office regulations on employee inventions.
- Do not know how to deal with warning letters.

Due to lack of awareness of IP.

- Do not know the methods of educating management and employees.
- Do not know how to prevent leakage of technical information on joint R&D and clients.







Fee Reduction Measures (including patent fees)



- Measures to reduce patent related fees including patent fees are available at the JPO.

 Reduction of examination request fees as well as patent fees are available for poorly funded SMEs, SMEs specializing in R&D, and manufacturing SMEs
- ➤ With relaxation of requirements and simplified procedures to promote the use of this program, its usage has been on the rise




Support of Free Prior Art Searches



➤ At the request of applicants, private research agencies conduct prior art searches free of charge.

This program offers information necessary for SMEs in making a decision on whether to make a request for examination of their application.

- SMEs can save examination request fees for patent applications that are unlikely to become patents.
- JPO can eliminate useless examinations of applications that lack novelty and inventive step, thus contribute to speedier and more appropriate examination processing.




Accelerated Examination System



➤ An easy-to-use system for SMEs wishing to promptly obtain patents


Time required for issue of the notification of the first examination result: **2.0** months from the application for accelerated examination (normally 29 months)



Deferred Payment System of Examination Request Fees



In response to the recent recession, we introduced an emergency measure to reduce the financial burden on companies etc. where applicants can defer the payment of examination request fees limited to one year from the submission date of the examination request, for requests submitted on and after April 1, 2009.



Automatic Payment System of Patent Fees etc. (JPO deposit/bank account)



Fees Covered by the Automatic Payment System

- ➤ For Patent Fee/Utility Model Registration Fee from the 4th year onwards and Design Registration Fee from the 2nd year onwards
- * The system does not apply to fee for registering establishment of rights or fee related to trademark rights.
- * The system does not apply to the following patent fees:

- Select a requester for jointly owned rights

- Name seal to confirm intention (or ID label) required

- Letter of proxy required for an agent

- (a) For patent rights which are jointly owned with the state and the quotas agreed upon
- (b) For the 4th to the 6th year in which reduction and exemption measures are applied
- (c) For a tax exempt corporation which deferred payment of patent fee and has not paid the patent fee for the 1^{st} to the 3^{rd} year
- (d) For renewal of registration for the period of duration

Patent fees are withdrawn from accounts on a yearly basis

- Prevents expiration of the right from failure of

- Becomes unnecessary to submit separate payment

- Becomes possible to decide whether to maintain the right



Grants for Foreign Applications



- ☐ It is crucial to accelerate innovation by encouraging SMEs' foreign applications.
- ☐ Making the most of Prefectural SME Support Centers will make it possible to take full advantage of regional characteristics, appropriately judge business potentials, and promote regional policy making.




To provide efficient and effective assistance to SMEs, this program is focused on the following viewpoints:

- <u>Selecting patent applications that have a high chance of being patented overseas (pre-screening investigation)</u>
 - A support system that conducts technology evaluation (prior art search) and market evaluation by setting up a panel of experts
- The status of foreign applications is confirmed in an ex-post report (ex-post follow-up)

SME IP Strategy Support Program



In order to promote the strategic utilization of regional SMEs' intellectual properties, we support the following program implemented by the SME Support Centers located in each prefecture.



1. Support for Patent Analysis

- .Patent map creation (depending on the intended use, patent data is collected, processed and analyzed, and made into charts and tables for easy use by users.
- .Citation analyses.relationship between cited and citation patents.
- .Support for utilization of the patent licensing support chart

2. Patent Strategy Formulation

- .R&D strategy formulation.review and formulation of R&D plans based on market trends and comparison with the patents of other companies.
- .IP strategy formulation.comparison of profit and cost, the trend of overseas market trends and review of company's manufacturing, market development and sales capabilities, and know-how on IP protection)

3. Support for Patent Evaluation for Business Purposes

.Support for business plan formulation and for financing based on the evaluation of patents




Promotion of Patent Licensing



- ➤ Promotion of patent licensing in the interest of activating new product/business development by SMEs and venture enterprises through the smooth transfer of open patents owned by universities, research institutions and companies
- > Implementation of mediation support by dispatching patent licensing advisors to prefectural offices and TLOs nationwide
- > Storing transferable patents in databases and offering them over the Internet (approx. 45,000 pieces)



[Trend in the number of cases of agreement signing via patent licensing advisors]






Regional IP Advisory Counters



☐ In July 2006, "Regional IP Advisory Counters," IP inquiry counters for SMEs, were set up at Business Community and the Chambers of Commerce and Industry across Japan.

Inquiry Counters: Offer counseling on IP or refer you to support institutions.

Seminars: Local-needs oriented seminars or IP consultations with IP specialists are held.



Regional IP Advisory Counters

2,300 shelters in Japan (Business community and chambers of commerce and industry)

(3)Specialist consultations that respond to your problems are available.

Support (specialized) institutions

Commercial/Industrial Associations: Regional organization comprised of businessmen; interested in local development of their industry and regional economy, and active in a variety of projects irrespective of the field of their business operations in about 2,000 municipalities).



Service Description.

- 1. Establishing an unified contact aiming at cooperation with assistance organizations for regional SMEs
- 2. Stationing coordinators who are able to appropriately make decisions and take actions for SME problems and challenges by precisely understanding and acknowledging them
- 3. Dispatching IP experts directly to SMEs where technical training is conducted
- 4. Conducting consultation meetings where IP experts are involved in individual guidance/advice consultations
- 5. Explaining IP assistance measures and details on related procedures for SMEs to be able to use
- 6. Supporting users in making applications for patents etc. (including Internet application procedures)




Industrial Property Rights Specialists
