
# Intellectual Property Management

# **Workshop aims**

Hosted by the World Intellectual Property Organization (WIPO), this two-day workshop will improve participants' understanding of Intellectual Property (IP) management through an in-depth analysis of innovative real-life products. Discussions will explore the interconnections between IP and business processes at all stages of product development and management.

Panels will be led by leading IP experts from the Hanken School of Economics, the Harry Radzyner Law School, Queen Mary University of London, Texas A&M School of Law, the University of Copenhagen Center for Advanced Studies in Biomedical Law and the University of Gothenburg in collaboration with the Center for IP at Chalmers University of Technology.



## **Product analysis**

Participants will have an opportunity to analyze innovative products from across the gaming, health, food and beverage, and fashion, apparel and luxury goods industries. Separate sessions will be devoted to each industry for the presentation of in-depth analyses.

#### **Gaming industry**

#### Cyberpunk 2077

Cyberpunk 2077 is one of the most anticipated games to be released in 2020. The Warsaw-based developer – CD Projekt RED – worked on the game for five years and received a US\$7 million subsidy from the Polish government. Set in the futuristic metropolis of Night City, Northern California, Cyberpunk 2077 is based on a role-playing board game created by renowned game designer Mike Pondsmith.

#### **LV Archlight Trainers**
