

Strategic direction of WIPO

New era of intellectual property

- Growing demand for new forms of IP protection
- Greater global coverage
- Greater use of IPRs (including non-traditional areas)
- Potential new beneficiaries of IP



- Renewed focus on human resources development ___
- Anticipate greer demand from policy makers for information, analysis and trends
- Expect closer involvement of market sector and civil society in emerging areas



- Created in 1998
- Objective to serve as an educational institution providing and coordinating teaching, training and research in IP
- Strategic combination of programs:
 - Distance Learning
 - Professional Training
 - Policy Development, Teaching and Research



- Wide and diversified target groups:
 - IP professionals
 - Government officials
 - Policy makers, i.e., ministries of justice, trade, science and technology
 - Enforcement agencies
 - Private industry
 - Academic community
 - R & D institutions
 - Users of IP in civil society



Effects on training approaches

- Traditional and conventional areas of IP
- New and emerging areas (TK, Ecommerce + open software, access to medicine, ethics in biotechnology and patents, etc.)
- New focus on economic aspects of IP



Effects on training approaches

- Multidisciplinary approach (law, economics, political science, natural sciences, medicine, etc.)
- Interface with other areas (human rights, bio-diversity, environment)
- Customization of programs to level of interest



Registrations 1999-2003 over 19,000 students





Distance Learning

Facts and figures:

- over 6000 students per year
- 7 languages
- 170 countries including developing and industrialized
- 90 tutorial sessions per year
 Strong DL pedagogy based on tutorial support



Professional training

- Objective: to strengthen the professional skills in IP in developing countries and countries in transition
- cooperation with partner institutions
- mix of theoretical and practical training sessions (+ DL)



- Inter-regional intermediate seminars (IP, CR), followed by:
- Practical training
- Advanced training courses, i.e., legal, administrative, economic aspects of industrial property; claims drafting; patent search and examination procedures; collective management of CR & RR



Policy Development

- Objective: build multidisciplinary capacity in IP policy among decision-makers, policy advisors, diplomats, professors, etc.
- Skilled cadre able to
 - ensure adequate IP protection
 - develop the IP system
 - manage IP assets



Teaching and Research

- Contribute to the training of trainers
- Undertake the development of teaching & training materials and curricula on IP
- In cooperation with other institutions of excellence

Criteria:


- program objectives
