Fusion for Energy (F4E), the European Union's Joint Undertaking for ITER and the Development of Fusion Energy in collaboration with the European Commission (EC) and the World Intellectual Property Organization's Arbitration and Mediation Center (WIPO Center) is organising a conference in Barcelona, Spain (Hotel Diagonal Zero) on 28 and 29 November 2011.

The conference is addressed to project managers, in-house Intellectual Property (IP) practitioners and, in general, any representatives from companies and research institutions operating with F4E or which are considering their involvement in our activities.

The aim of the conference is to raise awareness amongst potential F4E contractors and beneficiaries about the management of IP in the fusion programme, to consider the opportunities that fusion research may offer for innovation and technology transfer, to analyse dispute prevention and resolution techniques in the area and to present some practical tools for dealing with IP.
