Subsequently was consulted by the Japanese Special Law Committee which was formed by Government of Japan to seek suggestions on improvement of Japanese Arbitration Laws in 1996:

Represented the Ministry of Defence, Government of India as its Counsel in defence arbitration matter at London;

Conducted international commercial arbitration administered by ICC Paris between an Indian Company and a Chinese company with venue at Singapore;

Interacted with eminent jurists in India and abroad as an arbitration expert and Secretary-General of

Indian Society of Arbitrators during 1994-97; During last seven years, has been appointed seven times by international bodies to decide International Intellectual Property disputes.
