Ty, Inc. v. West Highland Publishing, Inc., 1998 U.S. Dist. LEXIS 15869 (October 2, 1998): Trademark litigation; represented the plaintiff, and successfully obtained a preliminary injunction.

Suncast Corp. v. Avon Plastics Inc., 1999 U.S. Dist. LEXIS 15222 (September 21, 1999): Patent litigation; represented the plaintiff, and successfully argued against defendant's motion for summary judgment on the issue of infringement.

Wanlass et al. v. General Electric Corporation, et al., 1997 U.S. Dist. LEXIS 22729 (July 21, 1997): Patent litigation; represented the defendant General Electric against plaintiff seeking in excess of US\$ 450 million; successfully won motion for summary judgment on issues of laches and estoppel, resulting in dismissal of plaintiff's action against General Electric.
