Key Actions

- ❖ Fast-track utilization of WIPO's Technology and Innovation Service Centers (TISC) program in higher education and research institutions
- Fully utilize WIPO's contemporary Access to Scientific Publication and Information (ASPI); Access to Research for Development and Innovation (ARDI); and other similar resources
- Support the creation of Technology Transfer Offices (TTOs) and processes in higher education and research institutions

IP POLICY CON'T

- ❖IP Policy under review for MUST
- We however we continue to encourage TISCs to conclude their IP policy since we provided a guiding Template.

CHALLENGES

- Skills gap amongst the focal persons in the various institutions to offer the required assistance to other researchers.
