July 2012

Access to AU application data and documents through web services

September 2013

Access to PCT application data and documents

April 2014

Access to JP application data and documents under CASE – OPD linkage pilot



April 2015

- Release of WIPO CASE 3.0
- Offices operational under CASE framework
 - AU, CA, GB, IL and CN as both **Depositing** and **Accessing** Offices
 - MN, NZ, IN, BN, ID, LA, MY, PH, SG, VN and CL as Accessing Offices
- Offices operational under CASE OPD linkage pilot
 - AU, CA, GB, IL and JP as both Depositing and Accessing Offices
 - ID, PH and MY as Accessing Offices
- PCT data operational under CASE framework and CASE OPD linkage pilot

WIPO CASE Service – Patent Family

Patent Family Data

- National applications and PCT applications
 - Application (numbers and dates)
 - Publication (numbers, kind codes and dates)
 - Priority application (numbers and dates)
 - National phase entry application (numbers and dates)
- Covered with AU, CA, CN, GB, IL, JP, PCT, ID, PH, SG, MY, VN
- Family building includes only applications loaded in WIPO CASE
- Update daily

Simple search

- One level backward and then one level forward
- Extended search
 - All sets of applications related by priority or national phase entry

GB

Specification (A pub, B pub, Description), Claims etc.

Search statement, Examination report etc.

AU

- Claims, Description, Drawings etc.
- Patent Examination Report, Notice of acceptance etc.

JP

- Claims, Description, Drawings etc.
- Notification of Reason for Refusal, Decision to grant a patent etc.
 PCT
- Published international application etc.
- ISR, IPRP etc.



Possible Scene for Use of WIPO CASE

Routes for filing to offices

- > Domestic
- PCT route
- Paris Convention route



- Applications are filed by foreign applicants, and some come through PPH.
- In the case of applications filed from depositing offices like AU or JP, examination results at each office can be available on WIPO CASE.
- Examiners can search for patent family by using application numbers or priority numbers etc.

Benefit

Easy accessibility to Centralized Information

- All information displayed on one portal without referring to each offices' web site.
- Patent family DB to show globally relevant applications

Comprehensive Collection of Examination Results

Collection of documents covers whole examination procedure, e.g. search report and examination document until final decision.

Less Language Barrier by Translation

Documents in non-English language are translated by machine or manual translation.

Enhanced Functions of WIPO CASE

New WIPO CASE Web Portal

- Improved usability of user interface
 - Time line
 - Comparison of documents
 - Translation
 - Subscription and notification
 - Linkage to PATENTSCOPE

Other Functions Improved on WIPO CASE

- Citation data (GB)
- History of publication data (GB, PCT)

Future Development of WIPO CASE

Enhancement of Data Collection on WIPO CASE

- Addition of patent family data of participating offices
- Access to GB application documents through web services (same as IPSUM)
- Enhancement of accumulation of CA data
- Participation of More IP5 Offices under CASE OPD Linkage Pilot
 - Access to US and KR data under discussion
- Further Enhancement of Service
- Public service of CASE through PATENTSCOPE
- Communication platform with smooth linkage to CASE
