### WHO ARE WE?

- OA Government Department in the Ministry of Justice and Constitutional Affairs responsible for, among other mandates, the administration of Industrial Property Rights (IPRs)
- Headed by The Registrar General, who is assisted by a Deputy and a team of Assistant Registrars General
- We have three regional offices in Blantyre, Lilongwe and Mzuzu

### WHAT IS OUR MANDATE?

- •To administer, amongst other laws, the following Industrial Property legislation:
- ✓ The Trademarks Act (Cap. 49:01);
- ✓ The Patents Act (Cap.49:02); and
- ✓ The Registered Designs Act (Cap.49:05)

**ALL OF 1958** (with several amendments)

New Trademarks Bill before parliament, Zero Draft Patents Bill currently undergoing expert consultations phase



### STATUS OF AUTOMATION

- The office is currently using IPAS Java Version 2.70 for Trademark and Patents only
- \*80% of the Trademark workflow executed on IPAS, we are working on reviewing this and upscaling to 100%
- ♦ Approximately 76% (23,000 out of 30,000) TM records available on the database
- No IPAS usage for Industrial Design applications- Industrial Design applications still being processed manually
- ❖ Journal still being published by the Government Press awaiting ongoing legal reform and facilitating provision of electronic copies on our website and through ARIPO.



### STATISTICS

Approx. 35% of trademark records digitized, but not validated or verified

Approx. 65% of the records remain undigitised, largely comprising of dormant files



### CHALLANGES

- Very slow change in office culture (from manual to automated) affecting some critical back-end office processes on Trademarks which are still being done manually
- > Extremely low IPAS usage for Patents
- > High vacancy rates and staff turnovers



### **FUTURE PLANS**

#### **IPAS AUTOMIZATION PROJECT**

#### i. DATA VALIDATION AND VERIFICATION EXERCISE

Implementation Period: July, 2017 – February, 2018

Phase 1: **11,488** (verified as uncaptured) records (1958 – 1984)

Phase 2: (approx.) **9,000** records (1984 – 2005)

Phase 3: (approx.) **6,000** records (2005 – 2017)

#### ii. DIGITISE ALL RECORDS -WIPO SCAN

digitize IP paper documents in the IPAS EDMS and capture Patents and Industrial Design records as well.

#### iii. CREATE AND MAINTAIN A PAPERLESS WORK FLOW – IPAS EDMS

#### iv. ONLINE SERVICES

Provide an outward facing window for online survives, starting with search and journal publication
