IP POLICY, INSTITUTIONAL BACKGROUND AND STRUCTURE

- Namibia doesn't have an IP Policy in place jet
- IP audit and IP Policy formulation commenced in 2015 with the assistance of WIPO and its at an advanced stage now
- Business and Intellectual Property Authority is an autonomous body created by an Act of Parliament to administer Business and Intellectual Property matters
- The Authority is headed by a Chief Executive Officer
- Other Managerial Positions includes Executives for both IP Services and Business registrations followed by Managers on Patents, Trademark and Copyright Services

STATUS OF AUTOMATION

- IPAS was deployed in 2002 to the Namibian IP Office
- During the deployment phase, WIPO donated a server and three computers and a scanner as part of the automation package
- IPAS CENTURA as affectionately known by then were installed in all the donated workstations
- Over the years the database was upgraded to IPAS Java of which we are using version 3.1.1
- All new Applications are received and captured on IPAS ONLY
- All office documents currently issued by the office are generated and issued on IPAS and all past manual systems are buried and abandoned
- IPAS is user friendly and easy to operate
- There are only Trademarks data on IPAS at the moment

FUTURE PLANS OF THE IPO

- BIPA'S immediate plan is to ensure that all IP Data (Trademarks, Patents, Designs and Copyright) are captured, verified, validated and accounted for on IPAS
- Finalisation and implementation of the IP Regulations
- IP Policy to be finalised and implemented
- Embark on IP Online Services with the assistance of WIPO and ARIPO
- To send examiners and Searchers for Training in Vienna Classification to ensure effective classification and search of figurative elements
- To be one of a few IP Model Office in the Region

TRADE MARK STATUS RECORDS ON IPAS

- There are 97, 064 trade marks captured on IPAS
- In total we have 64,342 Trade marks in registered status on IPAS
- In total, 7686 records verified and validated
- 19786 marks in formalities exams on IPAS
- 5737 marks in Substantive examination response
- +- less than 1200 back files still need to be captured on IPAS

CONCLUSION

- In conclusion, we are doing all search and examination on IPAS.
- In the absence of Vienna Classification for the classification of figurative elements, searchers/examiners have to literally search through all logos in the class applied for including in conflicting classes to the one applied
