## Tanzania

#### Location

Tanzania is situated in East Africa, bordered by Kenya, Uganda, Democratic Republic of Congo, Malawi, Zambia, Mozambique, Rwanda, Burundi and the Indian Ocean

#### History

Tanzania gained its independence in 1961 and became a United Republic in 1964 through the union of two independent states of Tanganyika and Zanzibar.

#### **Government Structure**

 The United Republic of Tanzania is a unitary state based on the multiparty parliamentary democracy.

 The organs of the government are three; Executive, Judiciary and Legislature

### Sources of Law

 Tanzania legal system is based on the English Common Law system.  Business Registrations and Licensing Agency - BRELA
 BRELA is a semi-autonomous Government Executive Agency under the Ministry of Industry, Trade and Investment.

 It was established under the Government Executive Agencies Act No. 30 of 1997 Cap 245.

## BRELA...cont.

- It is responsible for business facilitation and regulation.
- Has a role as a central registry for Business Activities Registration Act (BARA) of 2007

It has three main technical departments;
a) Commercial Laws
b) Industry Licenses and;
c) Intellectual Property

Trade and Service Marks Trade and Service Marks are protected under Trade and Service Marks Act No. 12 of 1986 and Trade and Service Marks Act CAP 326 (R.E 2002).

The Act has played a major role on the protection, promotion and development of trade and service marks.

 However the government is in the due process of consolidating all Intellectual Properties laws together.

## Adoption of IPAS in Tanzania


- IPAS introduced for the first time in the year 2005
- Was known as IPAS Centura
- In the year 2008 WIPO introduced to us a new version known as IPAS Java a web based technology
- IPAS Java replaced the past system which is IPAS Centura
- Fully utilization of IPAS started in the year 2014

## Status of automation


- Before the year 2008 every staff was less concern with IPAS
- In year 2008 we started scanning marks and data capturing as we receive applications
- In the year 2014 is where we started fully from reception to post registrations applications
- Right now we are in good progress to introduce online registration in this year

T&S marks registration activities results for 2013-2017\*




