Background

INTELLECTUAL PROPERTY CORPORATION OF MALAYSIA (MyIPO)

- Corporatized 3 March 2003
- Intellectual Property Corporation Act 2002
- Responsible for the development and management of intellectual property system in Malaysia
- Semi-autonomous body
 - Able to recruit and train staff on its own terms
 - manage its own finance
 - Running operation based from income derived from registration
 - Launching grant of RM48 million (USD 15.5 million)
 - Taxation by the government 30 % of net income

"To be one of the leading IP organizations"



Functions

- Administer and enforce IP Legislations
- Administer, collect and enforce payment of prescribed fees / charges
- Regulate / supervise IP issues
- Review / update IP Legislations
- Organize training and disseminate infos on IP



Functions (cont.)

- Promote cooperation program at national and international level
- Safeguard Malaysia's interest in respect of any agreement or international convention to which Malaysia is a party
- Advise the Government on IP matters
- Conduct research and studies on IP issues


Patent System in Malaysia



Concept of Patent System in Malaysia

- First-to-File principle
- 18 months lay-open for public inspection of unexamined application
- Request for substantive examination : within 2 years from filing date
- Grace period provision
- Term of protection : 20 years from filing date
- Modified examination system:
 - supply foreign patents: EPO, USA, GB, AU, KR & JP
- Language English and Bahasa Melayu
- Opportunity for hearing before grant
- No opposition after grant
- Invalidation of patents through High Court





Services for Patent

- Receiving patent application and fees
- Examination as to substance
- Lay-Open for public inspection of patent application
- Publication of granted patent
- Refusal or grant patent
- Maintenance of patents



Patent Prosecution

Services For Patent (cont.)

- Application for compulsory licenses
- Patent information services
- Update the policy and legal aspects of patent law
- Supervise technical training for patent examiners
- Monitor registration and renewal of patent agents

MyIPO Patent Business

- ☐ Divided into two main divisions:
 - > The Formality Section
 - > The Patent Examination Section
 - Engineering Section
 - Applied Sciences Section



Patent Prosecution

EXAMINATION

2 stages in the examination process:

- Formality examination
 - Examination to comply with the formality requirements of the Act and Regulations
- Substantive examination
 - Search and examination to comply with the substantive requirements of the Act and Regulations

SUBSTANTIVE EXAMINATION

- Full Substantive Examination
- Modified Substantive Examination



Patent Prosecution

FULL SUBSTANTIVE EXAMINATION

- Request Full Substantive Examination Form 5
- Fee RM700 (USD 226)
- Full Search and Examination

MODIFIED SUBSTANTIVE EXAMINATION

- Introduced 1995
- To expedite the search and examination
- Request Form 5A
- Fee RM450 (USD 146)
- Submit foreign patent
 - EPO, GB, USA, AU, KR or JP
- Top-up Search and Examination







Malaysian Government Efforts

IP COMMERCIALISATION POLICY FOR RESEARCH & DEVELOPMENT PROJECTS FUND

- □ Fund by Government for research, development and commercialisation purposes
- □ Provided for Government Agencies & Research Institutes including Institutions of Higher Learning
- □Aims:
 - ➤ Establish common framework to regulate the ownership and management of IP
 - ➤ Promote and facilitate the protection of IP in line with NIPP
 - ➤ Promote and facilitate the exploitation and commercialisation of IP generated from projects funded by Government



Malaysian Government Efforts

POLICY PROVIDES GUIDELINES ON:

- □Exploitation of Intellectual Property
- □Disclosure and Evaluation of Invention
- **□**Commercialisation
- ■Wealth Sharing
- □Incentives for Invention

Malaysian Government Efforts

INCENTIVES FOR INVENTION

■ Upon Disclosure of Invention

➤Incentive: RM 500 (USD 161)

■ Upon Filing of Patent Application

➤ Incentive : RM 5,000 (USD 1,616)

■ Upon Grant of Patent

➤Incentive : RM 10,000 (USD 3,233)



MyIPO's Initiatives

PROMOTE GRANTING AND ENCOURAGE INNOVATION

- □Amendment of Act & Regulations
 - To facilitate granting of patents
- □Increase number of examiners
 - Recent intake of 25 formality and substantive patent examiners
 - > Next intake of 21 examiners
- □ Decrease pendency period
 - > Year 2012 : 24 months

MyIPO'S Initiatives

PROMOTE GRANTING AND ENCOURAGE INNOVATION

- □Upgrade IT infrastructure
 - > To facilitate faster patent application processing
- □Upgrade examiner's searching tools
 - ➤ To facilitate faster and more efficient search and examination
