

International search is made to ascertain the novelty of the invention.

No examination guidelines in addition to Patent Ordinance 2000 and Patent Rules 2003, and any case law applicable for interpreting them, are provided.

#### **Deferred Examination**

Deferred Examination is not allowed, i.e. it is not possible to file an application and request examination at a later stage.

# Request For Information From The Applicant

U/S 20 of the Patents Ordinance 2000, the applicant shall, when required by the Controller, furnish him with the date and number of any application for a patent filed by him abroad. He may also be required to submit the following documents:

(i) a copy of any communication received by the applicant concerning the results of any search or examination carried out in respect of the foreign application;

- (ii) a copy of the patent granted on the basis of the foreign application; and
- (iii) a copy of any final decision rejecting the foreign application.
- The applicant shall, when required by the Controller, furnish him with a copy of any final decision invalidating the patent granted on the basis of foreign application.

### Continued...

The legislation does not explicitly authorize granting of patents based on claims granted by other patent offices. However, preference is given to patent applications granted in EP, US, Germany and Australia, if they so comply with the requirments of Patents Ordinance 2000.

### **Timelines**

At the present time, no official timelines for actions by the examiner or the applicant are in exercise. Hence the applicant is not bound to reply within a certain time limit.

- The Controller, U/S 53 of the Patents Ordinance 2000, shall give to any applicant for a patent or for amendment of a specification, if within the prescribed time the applicant so requires, an opportunity of being heard before exercising adversely to the applicant.
- Frequency of hearings varies, and hearings are conducted within 10 to 15 days after receiving of request from the applicant.

## **Types Of Claims**

- According to Section 15(4) of the Patents
  Ordinance 2000, the claim or claims of a
  complete specification shall relate to a single
  invention, shall be clear and succinct and
  shall be fairly based on the matter disclosed
  in the specification.
- Usually 3 independent claims are allowed, but there is no bounding from the Patents Ordinance 2000.

### **Advisory Services**

The Patent Office Karachi, has established an IP helpline to provide support services to the R&D institutions as well as individual researchers in getting their inventions and creations registered for protection and commercialization.

## **Challenges In Substantive Examination**

- International Search Report (ISR) interpretation
- International Preliminary Examination Report (IPER) interpretation
- Judgment/interpretation of novelty & inventive step from specification, embodiments and diagram.
- How to differentiate that an invention lacks novelty/inventive step or both?

- How to raise objections:
  - i) If we want applicant to limit claims.
  - ii) Scope of "Markush Claims' too wide.
  - iii) To avoid selection patent.
  - iv) When diagrams are not clear
- What is information disclosure statement and why it is needed?
