HENNING GROSSE RUSE - KHAN

Dr. Grosse Ruse - Khan is a senior research fellow at the Max Planck Institute for Intellectual Property and Competition Law in Munich (Germany). He frequently teaches international intellectual property (IP), world trade and investment law at institutions in Europe and Asia.

Next to a monograph on international intellectual property protection, Henning has published widely in peer-reviewed international academic journals, NGO policy papers and research handbooks. Henning previously worked in Universities in the United Kingdom, Germany, Malaysia and Pakistan and has advised international organizations, NGOs as well as governments on international IP, WTO and investment law issues. In 2011, he was elected as associate fellow at the Centre for International Sustainable Development Law (CISDL, Montreal, Canada).

LES McCAFFERY

Mr. McCaffery is a Supervising Examiner of Patents at IP Australia, and currently heads the Biotechnology section. He has previously headed the training and Organic Chemistry sections. He has worked in various areas of IP Australia, including the Domestic Policy area where he worked on the current reforms to the Australian IP system. Les is also a Hearing Officer and has worked in the Opposition, Hearings and Legislation area.

Les holds a Bachelor of Science degree from the University of Newcastle in Australia, and a PhD in Chemistry from the Australian National University.

SHIMPEI YAMAMOTO

Mr. Yamamoto is Director of the Regional Policy Office, International Affairs Division, the Japan Patent Office (JPO).

He joined the Japan Patent Office in April, 1991 as an Assistant Examiner. He became Director of the Regional Policy Office of the International Affairs Division in January, 2011. He and his team are involved in planning cooperation with countries in Asian region, South American region, Middle East region and African region. They conduct bilateral, pluri-lateral and multilateral policy discussions and establish cooperative mechanism with countries in those regions. They also cooperate with WIPO and Japan International Cooperation Agency (JICA) to implement cooperation activities.

He worked for the Trade Policy Bureau of the Ministry of Economy, Trade and Industry (METI) as the Director for Intellectual Property from October 2008 to December 2010. He was in charge of the negotiation of IP Chapter of several Economic Partnership Agreements then.

Furthermore, He was the Deputy Director of the Examination Standards Office of JPO from January 2003 to June 2004. As the Deputy Director of the Examination Standards Office, he was involved in the negotiation of the Substantive Patent Law Treaty. He was a member of the Japanese delegation for the Standing Committee on the Law of Patents of WIPO in 2003 and 2004. He also established several standards and practices of examiners at the Examination Standards Office. One of the practices he established was the practice for technical evaluation reports of utility model.

He has also spent almost half of his career in the Japan Patent Office as an Examiner or an Appeal Examiner in the field of mechanical engineering.

He obtained a Master's Degree in Engineering in March 1991 and a Bachelor's Degree in Engineering in March 1989 from the University of Tokyo, Japan.

MARCO M. ALEMAN

Mr. Marco M. Aleman joined the World Intellectual Property Organization (WIPO) in 1999 as a Senior Program Officer working at the Economic Development Bureau for Latin America and the Caribbean. In 2006 he was designated Deputy Director of the Division for Public Policy and Development. Actually is the Deputy Director of the Patent Law Division and Head of the Legislative and Policy Advice Section. Before joining the Organization, after having completed five years of private practice on IP matters, Mr. Alemán was the Head of the Colombian Industrial Property Office (1995-1998). Also he was a fellow visiting researcher at the Max Planck Institute in Munich, Germany (1998). Mr. Aleman is the author of two books on IP (Andean Legal Framework on Trademarks, published in 1994 and Colombian National Legislation on Industrial Property, published in 1996) and several articles on IP matters. Mr. Aleman received his Law Degree (Javeriana University, Bogotá 1991), Corporate Law Certificate (Javeriana University, 1993); a Master at the University Alcalá de Henares (Madrid, Spain, 2005) where he is currently a Ph.D. candidate.

INTAN HAMDAN-LIVRAMENTO (MRS.)

Mrs. Intan Hamdan-Livramento is an Economic Officer in the Economics and Statistics Division of the World Intellectual Property Organization (WIPO). She is an innovation economist, responsible for conducting and supervising parts of the division's work relating to the economics of intellectual property (IP). She also lectures graduate level students at the École Polytechnique Fédérale de Lausanne (EPFL) in Lausanne, Switzerland and the Chinese University of Hong Kong in Hong Kong, SAR. Prior to joining WIPO, Intan gained over five years of international trade experience working at the World Trade Organization and the International Monetary Fund as a Consultant and Project Officer, respectively. She received her doctoral degree in the Economics of Innovation from EPFL in 2009. Her thesis is titled, "Examining How TRIPS Implementation Affects Access to Foreign Technologies for Developing Countries."
