



### SHOULD WE CARE ABOUT PATENT QUALITY?

Patent quality is the capacity of a granted patent to meet (or exceed) the statutory standards of patentability most importantly, to be novel, involves an inventive step, and be clearly and sufficiently claimed and described.



### **IMPORTANCE OF PATENT QUALITY**

### Low patent quality can cause:

Uncertainty about the validity of granted patents; the scope of granted patents; whether a particular invention is patentable; and whether a valid patent will be fully enforced.



### THESE UNCERTAINTIES CAN LEAD TO

The increased of disputes over patents, and more uncertain patents means that litigation becomes more complex and expensive, adding again to both the private and social costs of the system as a whole
