THE SCIENCE AND TECHNOLOGY **DEVELOPMENT LAW**

- > To carry out development of Science and Technology for promotion of industrial production contributory towards the National Economic Development Plans;
- > To carry out research and development for the increased extraction and utilization of domestic raw materials and the promotion of industrial production enterprises based on modern Science **Technology**

- ➤ To effect Technology Transfer for the promotion of production processes and the improvement of the quality of goods
- To nurture luminaries required for the development of Science and technology and for Research and development and to improve their qualifications
- ➤ To communicate and co-operate with domestic and foreign research institutes and organizations for the development of Science and Technology and Research and Development;
- To honor and grant appropriate benefits to outstanding luminaries and inventors in the field of Science and Technology.



TECHNOLOGY TRANSFER

- ➤ Allowing the right to use the Technology to any person free of charge.
- Selling or allowing the right to use the Technology, upon payment.
- Contracted period of time within the country under a contract.
- ➤ The manner and conditions relating to domestic and foreign Technology Transfer, shall be as determined by the Government.

- In transferring Technology by Technology department or government;
 - Monetary benefits may be granted in the prescribed manner to the relevant inventor or to persons who are mainly instrumental in the development of the technology
 - If the person who has obtained the right to use the Technology so desire, he may assign the duties to the inventor or to persons who are mainly instrumental in the development of the Technology in accordance with the existing regulations and bye-laws for government



TECHNOLOGY TRANSFER CONTRACT

- Contracts for Technology Transfer under section 10 sub-Section b shall contain the following facts:
 - Nature and applicability of the Technology transferred;
 - Type of Technology, the nature and amount of the financial payment;
 - Period for which the transferred Technology may be used;
 - Rights and responsibilities of the transferor and transferee of the transferred
 - Other agreements



TECHNOLOGY TRANSFER CONTRACT REGISTRATION

> Registration office for the registration of Technology Transfer contracts.

- > A contract for Technology Transfer:
 - shall be registered in the prescribed manner;
 - unless registered, there shall be no right of instituting a suit based thereon



IP SYSTEM IN MYANMAR

- > a focal Ministry for the WIPO and IP matter
- > draft new IP laws
 - Patent
 - Trademark
 - Industrial Design
 - Copyright

in cooperation with UAGO base on TRIPS, WIPO convention and treaties

At present, the finalized draft laws have been sent to the UAGO in order to receive the legislative advice on them.

After amending the draft laws according to the comment by UAGO, MOST will continue to submit these laws to the parliament through the cabinet in line with provisions.
