

ROAD TO ACCESSION

- •2004: 1st considered accession
- •7 years until the submission of the Recommendation for Accession to the Department of Foreign Affairs
- •September 2011: Submission to the Department of Foreign Affairs
- •April 25, 2012: Deposit the Instrument of Accession to WIPO
- •July 25, 2012: Entry into force
- •85th Contracting Party of the Madrid Protocol
- •3rd ASEAN member after SG and VN

 - Business groups



Improvement in the Operations of IPOPHL's Bureau of Trademarks

- 2005: Average first action dependency or Turnaround-time (TAT):
 - Filing of the application to issuance of first (1st) action:
 20 months
 - \circ Filing of the application to registration: 47 months
 - Use of the automated system (TEAMS or Trademark Electronic Application Management System), close monitoring of applications, revised work standards, rationalization of assignment of workloads to examiners



- 2010: Average first action dependency or Turnaround-time (TAT):
 - Filing of the application to issuance of first (1st) action:
 4 months
 - Filing of the application to registration: 10 months
- Clean-up of trademarks database, reengineering of business processes and implementation of Industrial Property Automation System (IPAS)



- Revision of Trademark Regulations and the Rules and Regulations Implementing Madrid Protocol
- Set up the Madrid Desk
- Training of at least three (3) examiners
- Information dissemination campaigns and training of users of the Madrid System







MADRID OPERATIONS

MADRID UNIT

- Reconstitution: December 2013
- All processes relating to International Applications (IAs) and International Registrations (IRs)
- 8 members and 1 Madrid Unit Head
- Examination of IRs is concentrated on the Madrid Unit
- Set-up a matrix of responsibilities and a work schedule



RESPONSIBILITIES

- Processing of International Applications (IAs)
- Downloading of IRs from WIPO server
- Printing of PDF notifications downloaded from the FTP server
- Addressing irregularity notices
- Issuance of ceasing of effect
- Scanning of documents for transmittal
- Coordination with the Bureau of Legal Affairs
- Electronic transmittal
- Preparation of Statement of Grant of Protection (SGP)
- Issuance of Statement of Account
- Initial Publication of IRs received
- Publication of allowed IRs
- Preparation of statistical information

PROCESSING OF IAs

- MM2 form is filed with the Duty Officer of the Bureau of Trademarks and is forwarded to the Madrid Unit (MU).
- MU officer checks all entries of MM2 before forwarding to MU Head for certification
 - If there are items to be corrected or amended, an email is sent to the applicant/agent for the submission of an amended form.
- MU Head does a final check before certifying
- Certified application is scanned and transmitted to WIPO via ftp



IRREGULARITIES

MOST COMMON REASONS:

- Fees:
 - Deficiency in fees due to exchange/conversion rates and bank service charges
- Classification and description of goods and services
