## 24th. MEETING OF THE PREPARATORY WORKING GROUP

## Proposal to modify part of the text of head class 45

It is important to add in head class 45 the following: "Personal and social services rendered by others to meet the needs of individuals, (not included in other classes)". The purpose of this, is to avoid the invasion of other services that may correspond in other class, but does satisfy the needs of individuals.

## Existing indications that need to be deleted.

Delete from class 18, base number 180091 and series number C0207: "Cases, of leather or leatherboard".

The reason for this is because it causes confusion regarding what is established in the general observations(letter f): "Cases adapted to the product they are intended to contain are in principle classified in the same class as the product".

## Proposals of New indications

The services regarding filling and toner filling for printers, is proposed to be classified in Class 37, since it is a nalogue to computer hardware (Installation, maintenance and repair of-) series C0079, base number 370116.


The renting of air conditioning apparatus is proposed to be classiffied in Class 40, since it is analogue to "Air freshening, series A0021, base number 400**O82**, or to "Rental of generators", series R0047, base number 400104.

The information services of traffic, is proponed to be classified in Class 45, as an information service for the citizens to give them a better option regarding traffic.

The service of automobile localization through a computer, is proposed to be classified in Class 45, since it is analogue to "Monitoring of burglar and security alarms", series M0044, base number 450194.
