The preferable class for these items would be 7 because they are tools and it would be more consistent with the contents of the two classes in question. This type of tools are commonly used in heavy industy, such as shipbuilding, and don't seem to fit in class 9. The item 'welding electrodes' is a little different, but as electrodes for medical use are in class 10, it may be logical to have this in class 7. Moreover, the sentence 'apparatus and instruments for conducting, switching, transforming, accumulating, regulating or controlling electricity' does not cover this kind of goods, and neither do the other ones in the class heading.

090375 Sealing plastics (Electrical apparatus for -) [packaging]

As these are devices for packaging purposes and also commonly used in industry, they would possibly fit better in class 7 in analogy with packaging machines.

090569 Flat ironsn, electric 090569 Irons (Flat -), electric

There are smoothing presses, pressing machines, electric cleaning machines and apparatus in class 7, as well as other electrically operated household utensils, why it might be appropriate to transfer these items to it, too. The present class heading does not seem to indicate the inclusion of this type of goods in class 9, either.

AJVAR is a traditional Macedonian product, although the word AJVAR is a generic term for that product widely known and prepared in the Balkan region.

The goods covered by this term are a layer of paint film which can be used, for example, on a wall instead of using a tester pot of paint. They are repositionable so that they can be placed in different parts of a room as necessary. There was some debate regarding whether this product should be classified in Class 2, by analogy with paints, or whether it should be classified in Class 16, by analogy with colour sample books. It was decided that Class 2 is the correct classification because repositionable paint patches are still essentially patches of paint.

3		Air fragrancing preparations

The products covered by both of these terms may be referred to as 'air fresheners' in advertising literature but they have distinctly different functions and are classified in different classes. Air fragrancing preparations perfume the air but air deodorising preparations remove odours from the air rather than replace or mask the odour with a fragrance. See also the proposal to add "-room fragrancing preparations" to the explanatory note relating to Class 3, and the proposed deletion of "Air freshening preparations" from Class 5.

These new indications are relevant to the field of biotechnology. There is a growing market for these goods. See also the proposal to change "Biological preparations, other than for medical or veterinary purposes" to "Biological preparations [other than tissue cultures], for industrial purposes".
