RULESOFPROCE DURE OF THE COMMITTEE OF EXPERTS OF THE IPCUNION

adopted by the Committee of Experts of the IPCU nion

(Article5(4)oftheStrasbourgAgreementConcerningthe InternationalPatentClassification(of1971),asamendedin1979)

Rule1: ApplicationoftheGeneralRulesofProcedure

The Rules of Procedure of the Committee of Experts of the IPCUnion (here in after called "the Committee of Experts") and of the subcommittees and the working groups established by it, in accordance with Article 5(3) (v) of the Strasbourg Agreement Concerning the International Patent Classification (of 1971), as a mended in 1979 (here in after referred to as "the Agreement"), shall consist of the General Rules of Procedure of WIPO, supplemented and amended by the provisions of the Agreement, by the resolution of the Assembly of the IPCUnion of October 7, 1975, and by the provisions set for thhere in after.

${\it Rule 2:} Representation and {\it Expenses of Delegations of Member States and Organizations}$

(1) EachdelegatemayrepresentoneStateonly.

(2) The expenses of each delegation shall be borne by the Government or the Organization which has appointed it.

Rule3: Sessions

(1) TheCommitteeofExpertsshallmeetinordinarysessionatleastonceevery two yearsonconvocationbytheDirectorGeneral.

(2) The Committee of Experts shall meet in extra ordinary session on convocation by the Director General at the request of one-four those the States members of the Committee.

(3) Subcommittees and working groups established by the Committee of Experts shall meet at such times and at such places as may be determined by the Director General in consultation with the Chair of the subcommittee or working group concerned.

Rule4: SubcommitteesandWorkingGroups

(1) Whenes tablishinganysubcommitteeorworkinggroup,theCommittee ofExpertsshalldetermineitstermsofreferenceandthefrequencyofits sessions,andshalldesignateitsmembers

 $(i) \ from a mong the States members of the IPCU nion, and$

 $(ii)\ from such States which ar\ enotmembers of the IPCU nion, without the right to make proposals for a mendment stothe Classification.$

(2) TheAfricanIntellectualPropertyOrganisation(OAPI),theAfricanRegional IndustrialPropertyOrganization(ARIPO),theEurasianPatentOrgani zation(EAPO) and the EuropeanPatentOrganisation(EPO) shall be invited to participate in the sessions of any subcommittee or working group established by the Committee of Experts.

Rule5: Observers

(1) MemberStatesofWIPOwhicharenotmembersof theIPCUnionmayparticipate asobserversinsessionsoftheCommitteeofExpertsandofanysubcommitteeorworking groupestablishedbytheCommitteeofExperts.

(2) TheCommitteeofExpertsmayinvitetoparticipateasobserversinitssessions ando fanysubcommitteeorworkinggroupestablishedbytheCommitteeofExperts interestedintergovernmentalorganizationsandinternationalnon -governmentalorganizations, aswellasorganizationsprovidinginformationservicesinthefieldofpatentinformat ion, providedthatnotopicsthatmaygiverisetoconflictofinterestareincludedintheagendaof thesession.

Rule6: StatusofIntergovernmentalOrganizationsReferredtoinArticles5(2)and 5(4)of theAgreement

(1) Article5(2)(a)oftheAgree mentshallapplytotheAfricanIntellectualProperty Organisation(OAPI),theAfricanRegionalIndustrialPropertyOrganization(ARIPO),the CouncilofEurope(CE),theEurasianPatentOrganization(EAPO)andtheEuropean Patent Organisation(EPO).

(2) AsfarastheAfricanIntellectualPropertyOrganisation(OAPI),theAfrican RegionalIndustrialPropertyOrganization(ARIPO),theEurasianPatentOrganization (EAPO)andtheEuropeanPatentOrganisation(EPO)areconcerned,Article5(4)ofthe Agreement shallalsoapply. Rule7: Officers

(1) Inthefirstmeetingofacalendaryear,theCommitteeofExpertsshallelect a ChairandtwoVice -Chairs.Theyshallremaininofficeuntiltheelectionofnew officers.

(2) Anysubcommitteeestablishedbythe CommitteeofExpertsshallhaveaChair andtwoVice -Chairs.Theyshallbeelectedbythesubcommitteeinthefirstmeetingofa calendaryear.Theyshallremaininofficeuntiltheelectionofnewofficers.

(3) AnyworkinggroupestablishedbytheCo mmitteeofExpertsshallhaveaChairand oneVice -Chair.Theyshallbeelectedbytheworkinggroupinthefirstmeetingofacalendar year.Theyshallremaininofficeuntiltheelectionofnewofficers.

(4) AnyoutgoingChairorVice -Chairmaybeim mediatelyre -electedtotheoffice whichhehasheld.

(5) WheretheChairorActingChairistheonlymemberofthedelegationoftheState ofwhichheisanational,hemayvoteinhiscapacityofdelegate.

(6) Representatives of the intergovernmental organizations referred to in Rule 6(2) may be elected as officers of the Committee of Experts or of any subcommittee or working group established by the Committee of Experts.

Rule8: PublicationoftheReport

Thereporton the work of each session of the Committee of Experts, or a summary drawn up by the International Bureau, shall be published in the review *WIPOMagazine* or on the WIPOW ebsite on the Internet.
