WIPO Authority File Portal (1)

- An authority file is a complete list of patent documents published by an IP Office.
- WIPO ST.37 is the Standard which defines which data elements should form part of an authority file in one of two recommended formats : text and XML.
- Each IPO entry includes:
 - the authority file itself (TXT or XML file)
 - optional definition file (see Annex I)
 - data coverage of authority file (e.g., from 1990 onwards)
 - any relevant remarks (e.g., update frequency)

Progress on Authority File Portal

- WIPO ST.37 revision approved at CWS/8 was published in December 2020: changes to the XML schema/DTD.
- Two updates to the portal published since CWS/8: April and June 2021.
- Recently received updates will be published after CWS/9.
- Data coverage column now standardized format
- The current participants are shown on the next slide. The majority of Offices still provide their authority file data in TXT format but five Offices provide in XML format.



Important!

- Although the proposed revision to ST.37 includes three new indicators it is NOT yet mandatory for ISAs to include these new fields
 - These are indicators for whether:
 - full text in available in searchable text format;
 - original abstract is available in searchable text format; and
 - English language abstract is available in searchable text format
- However, these CAN already be included if the revision is approved at this session

Next Steps

- February 2022: International Bureau requests via Circular for Offices to provide annual update in March
- Early 2022: A guide supporting Offices to provide their authority files will be published next year
 - Reminder (1): Some Offices neglected to update their authority files since their first submission. These should be updated at least annually. If updates are more frequent then these must also be sent to WIPO.
- Reminder (2): Offices are reminded that if they host their own authority file data, they must still provide update to data coverage and remark columns.
