- THEREFORE, WE NEED TO STRENGTHEN MULTILATERAL DISCIPLINES FOR INTELLECTUAL PROPERTY RIGHTS ENFORCEMENT SO AS TO MAKE THE ILLEGAL BUSINESS OF COUNTERFEITING AND PIRACY A DREADFULLY EXPENSIVE AND SERIOUSLY RISKY VENTURE.
