
Framework for Program 17

- Strategic Goal VI: International Cooperation on Building Respect for Intellectual Property => inclusive and integrated approach
 - Development Agenda Recommendation 45
- Expected Result III.2: Enhanced human resource capacities able to deal with the broad range of requirements for the effective use of IP for development in developing countries, least developed countries (LDCs) and countries with economies in transition


The Scope of Capacity-Building Activities

- Activities are only organized at the request of the Member States or regional intergovernmental organizations
- Considerations taken into account when prioritizing requests :
 Justification of the activity, political will and commitment
 State of national legislation
 Capacity and readiness of training institutes to participate
 Previous assistance
 - No "one-size-fits-all" approach Programs developed in close cooperation with the MS involved to take into account prevailing social, economic and legal circumstances

Content of Capacity-Building Activities

Programs are tailored to meeting the demands and needs of the requesting Member State.

Two (cross-cutting) "pillars":

Topics inspired by the work of the ACE
 Topics on Part III of the TRIPS Agreement and its implementation

Topics Inspired by the Work of the ACE

Example of topics :

- Attitudes and perceptions of consumers towards IP
- Awareness-raising and education
- IP enforcement in the digital environment
- Challenges of the enforcement of IP rights, cooperation between law enforcement agencies and the role of the right holders
- Disposal and destruction of the IP infringing goods
- Mechanisms to complement IP enforcement
- Private international law issues in IP infringements

WORLD INTELLECTUAL PROPERTY ORGANIZATION 7

Topics on Part III of the TRIPS Agreement and Its Implementation

Example of Topics frequently raised:

- The general obligations and the need for fair and equitable procedures (Article 41 and 42)
- Border Measures (Articles 51 to 60)
- Evidentiary Issues (Article 50(1)(b), Article 43, and Article 47)
- Civil Injunctions (Article 50(1)(a) and Article 44)
- Damages (Article 45)
- The disposal outside the channels of commerce of IP infringing goods (Articles 46, 59 and 61)
- Criminal procedures and sanctions
