## Thirty-Fifth Series of Meetings Geneva, September 25 to October 3, 2000

## REQUEST TO INCLUDE THE TWO DAYS OF ISLAMIC FEASTS (*ID AL-FITR AND ID AL-ADHA*) IN THE OFFICIAL HOLIDAYS OF WIPO

Request from the Council of Heads of Arab Permanent Missions to the United Nations Office at Geneva

1. In a letter dated March 9, 2000, the Permanent Representative of the People's Democratic Republic of Algeria, acting in his capacity as Chairman, for the month of March 2000, of the Council of Heads of Arab Permanent Missions to the United Nations Office at Geneva (the Council), requested, on behalf of the Council, the Director General of the World Intellectual Property Organization (WIPO) to take into consideration the dates of the Islamic feasts of *Id al-Fitr* and *Id al-Adha* while programming the meetings convened by WIPO, and to include the dates of the said feasts among the Organization's official holidays. The text of the said letter appears in the Annex to the present document.

2. It is recalled that the United Nations (UN) General Assembly was seized with a similar issue in 1997 and, in consequence, adopted in Resolution 52/214 (Pattern of Conferences) two decisions. The text of paragraphs 5 and 6 of UN General Assembly Resolution 52/214 reads as follows:

"The General Assembly [...]

"5. <u>Decides</u> that henceforth the two holidays of Id al-Fitr and Id al-Adha shall be observed as official holidays of the United Nations at Headquarters, and at other duty stations where applicable, and that United Nations buildings at those locations shall be closed to the public on those days; "6. <u>Decides also</u> that no United Nations meetings shall be held on Id al-Fitr and Id al-Adha, which occur in 1998 on 29 January and 7 April, respectively, and requests the Secretary-General to ensure strict implementation of this decision and of paragraph 5 above when preparing all future draft calendars of conferences and meetings of the United Nations."

3. The WIPO General Assembly and the WIPO Coordination Committee are invited to pronounce themselves on the request contained in the letter set out in the Annex.

The Heads of Arab Permanent Missions, like the representatives of all Muslim countries, are looking forward to including these holy days among the Organization's official holidays — if it has not already done so — and reaffirm, however, the importance of non-programming of meetings during these two occasions as delegations of Muslim countries will be unable to participate in such meetings.

We look forward to your sincere cooperation and consideration.
