Having taken into consideration that the informal consultations on External Offices has already started, we will like to ask once again that the amendment the GRULAC requested in Program 20, paragraph 20.21, of the draft Program and Budget 2014-2015, be circulated to all Member States by the WIPO Secretariat in order to be incorporated in the said Program and Budget prior to the commencement of the WIPO Extraordinary Assemblies on 10th December, 2013.

For ease of reference, the GRULAC attaches the said amendment which was already circulated by the Secretariat to Member States during the 21st Session of the PBC in September, 2013.

The GRULAC wishes to state that it remains committed to a constructive dialogue in order to reach a compromise solution for the approval of the Program and Budget 2014-2015 and reaffirms its legitimate interest of having a new external office in the region.
