### STATUS OF THE MARRAKESH TREATY TO FACILITATE ACCESS TO PUBLISHED WORKS FOR PERSONS WHO ARE BLIND, VISUALLY IMPAIRED OR OTHERWISE PRINT DISABLED

Information document prepared by the Secretariat

This document provides information on signature and ratification of and accession to the Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired or Otherwise Print Disabled (Marrakesh Treaty or MVT).

1. On June 27, 2013, the Diplomatic Conference to Conclude a Treaty to Facilitate Access to Published Works by Visually Impaired Persons and Persons with Print Disabilities adopted by consensus the MVT.

2. This document provides an update on the status of the MVT and the progress towards its entry into force.

### A. MARRAKESH TREATY SIGNATURE

3. The MVT was opened for signature on June 28, 2013. In accordance with Article 17 of the MVT, the Treaty remained open for signature at the headquarters of WIPO for one year after its adoption, that is, until June 27, 2014.

4. As of June 27, 2014, the 80 eligible parties listed in Annex I signed the MVT.

#### B. MARRAKESH TREATY PROMOTION

5. Since September 2014, the Secretariat has organized five regional and inter-regional events for the promotion of the Marrakesh Treaty, namely in Kampala, Muscat, Praia, Singapore and Tbilisi.

6. The Secretariat has also engaged in a number of activities, including legislative assistance, at the national level.

## C. MARRAKESH TREATY RATIFICATION AND ACCESSION

7. Under Article 18 of the MVT, the Treaty shall enter into force three months after 20 eligible parties, as defined in Article 15 of the Treaty, have deposited their instruments of ratification or accession.

8. As of the date of this document, the WIPO Member States listed in Annex II have acceded to or ratified the Marrakesh Treaty.
