AtitsmeetinginSeptember1998,theWIPOGeneralAssemblydecidedtointegratethe BudgetandPremisesCommitteesintotheWIPOProgramandBudgetCommitteeand"to reviewthemembershipof theWIPOProgramandBudgetCommittee,composedofthe membersofbothCommittees,uponexpirationoftheircurrentterminSeptember2001,witha viewtoensuringadequategeographicalrepresentationoftheMemberStatesofWIPO" (see documentWO/GA/23/4 anddocumentWO/GA/23/7,paragraph26).

2. AtitsmeetinginSeptember2001,thematterconcerningthemembershipand compositionoftheProgramandBudgetCommitteewasnotincludedinthedraft ConsolidatedandAnnotatedAgenda.Followinginf ormalconsultationsamongtheregional GroupCoordinators,itwasagreedthatthedraftagendaforthe2002meetingoftheGeneral AssemblyshouldincludeanitemontheelectionandcompositionoftheProgramandBudget Committee(seedocumentA/36/15,pa ragraph19).Intheinterim,itwasagreed,asan exceptionalmeasure,thattheProgramandBudgetCommitteewouldretainamembershipof 33StatesuntilSeptember2002,whenthemembershipandcompositionoftheCommittee wouldbereviewed,asagreedupo nin1998inparagraph12ofdocumentWO/GA/23/4 (see documentA/36/15,paragraphs19to21).

3. Asaresultofthesaidinformalconsultations,theGeneralAssemblyunanimously electedthefollowingStatesasmembersoftheProgramandBudgetC ommitteefortheperiod September2001toSeptember2002:Algeria,Argentina,Bulgaria,Canada,Chile,China, CzechRepublic,Ecuador,Egypt,France,Germany,Honduras,Hungary,India,Japan,

Mexico,Morocco,Netherlands,Nigeria,Norway,Oman,Pakistan, RepublicofKorea, RussianFederation,Senegal,Slovakia,SouthAfrica,SriLanka,Switzerland(*exofficio*), UnitedKingdom,UnitedStatesofAmerica,UzbekistanandVenezuela(33).

4. TheelectionofthemembersoftheProgramandBudgetCommit teeinSeptember2001 wasbasedontheunderstandingthatitwasfortheperiodofSeptember2001to September 2002, and that the membership and composition of the Program and Budget Committee would be reviewed by the General Assembly at its September 2002 meeting (see document A/36/15, paragraph 21).
