# AMENDMENTTOARTICLE 9(3)OFTHECONVENTI ONESTABLISHINGTHE WORLDINTELLECTUALP ROPERTYORGANIZATION

**DocumentpreparedbytheSecretariat** 

- 1. The present document reports on progressin relation to the entry into force of the amendment to Article 9(3) of the Convention Establishing the World Intellectual Property Organization (the WIPO Convention). Although the process of amending Article 9(3) of the WIPO Convention preceded the establishment of the Working Group on Constitutional Reform (the Working Group), it is of obvious relevance to the reform of the constitutional structure of the Organization.
- 2. InSeptember 1999,theParisUnionAssembly,theBerneUnionAssemblyandthe WIPOConferenceunanimouslyadoptedanamendedtextofArticle 9(3)oftheW IPO ConventionlimitingthepossibletenureofDirectorsGeneralofWIPOtotwomandatesofsix yearseach(documentA/34/16,paragraph 148).Inorderfortheamendmenttoenterinto force,Article 17(3)oftheWIPOConventionrequireswrittennotificatio nsofacceptanceof theamendmenttobedepositedwiththeDirectorGeneralbythree -fourthsoftheStatesthat weremembersofWIPOatthetimeoftheadoptionoftheamendment(atthattime,therewere 172 MemberStatesofWIPO,thusrequiringwrittenno tificationsofacceptancefrom129of thoseStates).MemberStateswhichhavecommunicatedtheirwrittennotificationsof acceptanceatthedateofthepresentdocument,arelistedintheAnnex.
