1. This document contains information concerning the arrears in annual contributions and in payments towards the working capital funds.

2. The Annexes provide details of the unitary contribution system and report on the status of contributions and working capital funds for the 2018/19 biennium.

3. The following decision paragraph is proposed.

Arrears in Annual Contributions (Except for Arrears of the Least Developed Countries Placed in a Special (Frozen) Account Concerning the Years Preceding 1990)

1. The following table shows the arrears in contributions on June 30, 2020, under the unitary contribution system which has been applicable since January 1, 1994, and under the previously applicable contribution systems of the six Contribution-financed Unions (Paris, Berne, IPC, Nice, Locarno, Vienna) and of the World Intellectual Property Organization (WIPO), for States which are members of WIPO but not members of any of the Unions, with the exception of arrears in contributions of the least developed countries (LDCs) concerning the years preceding 1990, placed in a special (frozen) account, which are not shown in this table but are shown in the table in paragraph 4 below.

Observations

2. The total amount of the overdue contributions was, on June 30, 2020, almost 6.32 million Swiss francs (as shown in the above table), of which approximately 5.04 million Swiss francs concern the unitary contribution system, whereas 1.28 million Swiss francs concern the pre-1994 contributions in respect of the Contribution-financed Unions and WIPO. The total amount of arrears, almost 6.32 million Swiss francs, corresponds to 36 per cent of the total amount invoiced for contributions payable for 2020, this amount being almost 17.5 million Swiss francs.

3. Any payment that reaches the International Bureau between July 1 and August 31, 2020, will be reported to the Assemblies in a separate document.

Arrears in Annual Contributions of the Least Developed Countries Placed in a Special (Frozen) Account Concerning the Years Preceding 1990

4. It is recalled that, in accordance with the decision taken by the WIPO Conference and the Assemblies of the Paris and Berne Unions at their 1991 ordinary sessions, the amount of the arrears in contributions of any least developed country (LDC) relating to years preceding 1990 was placed in a special account, the amount of which was frozen as of December 31, 1989 (documents AB/XXII/20 and AB/XXII/22, paragraph 127). Such arrears in contributions, as at June 30, 2020, concerning the Paris and Berne Unions and concerning WIPO are shown in the following table. Any payment that reaches the International Bureau between July 1 and August 31, 2020, will be reported to the Assemblies in a separate document.

Basis for determining contributions

Each Member State's contribution is determined on the basis of the decisions taken in 2003 by the WIPO Conference and the competent Assemblies of certain Unions administered by WIPO in relation to the unitary contribution system (document A/39/15, paragraphs 166 and 167).

Determination of contributions

The amounts of the contributions for the 2018/19 biennium were approved on October 11, 2017, by the Assemblies of the Member States of WIPO and the Unions administered by WIPO (document A/57/12, paragraph 88).

1 The Paris Union Working Capital Fund was set up in 1978 and fixed at 2 000 000 francs (document AB/VII/23, paragraphs 301 and 302). Since this Union's assembly had decided to use the Working Capital Fund to cover the exceptional expenses of the Diplomatic Conference for the Revision of the Paris Convention (the 1980, 1981, 1982 and 1984 sessions and the preparatory and consultative meetings from 1984 to 1987), it also decided, at its 1983 session, to reconstitute the Working Capital Fund up to an amount of 2 000 000 francs (document P/A/VIII/3, paragraph 11.i). As a result, the Paris Union Working Capital Fund amounted, as at December 31, 2019, to 1 592 894.11 francs.

2 The Locarno Union Working Capital Fund was set up in 1973 and fixed at 30 000 francs (document AB/IV/35, paragraph 152). Following the accession of the Netherlands and the withdrawal of the United States of America, the Locarno Union Working Capital Fund amounted, as at December 31, 2019, to 29 494 francs.

3 The PCT Union Working Capital Fund was set up in 1983 and fixed at 2 000 000 francs (document PCT/A/X/3, paragraph 13(i)). Following the decision taken by the Assemblies of the Member States of WIPO and of the Unions administered by it, each as far as it is concerned, at its fifty-fifth session held in Geneva from October 5 to 14, 2015 (documents WO/PBC/23/8, A/55/4 and A/55/INF/11 (item 11)), the Member States of the said Union benefited from the reimbursement of their share in the Working Capital Fund (WCF) of the PCT Union by having this deducted from the assessed contribution due for the year 2016.
