



Industrial Designs - The Hague System

- Via our Patent Attorney
- Be one step further, protect the investments, keep the market monopole
- Industrial Designs are very dissuasive :
 - Very often used for letters of formal notice
 - No trial in our history (trials only occurred on technical patents)








Industrial Designs - The Hague System

- Advantages of The Hague System :
 - Better cost efficiency / budgets
 - Easier and centralized portfolio management
- High interest for new members in the system (Japan, South Korea, USA...)



R&D Budget – IP Budget

- Santos strategy :
 - 10% of our annual turnover is invested in R&D
 - I new product every I or 2 years (including restyling)
 - Each new product has an Industrial Design patent






FIG. 1 is front view showing the new design of a blender according to the


